The Department of Finance (1), in exercise of the powers conferred by sections 8A and 8B of the Government Resources and Accounts Act (Northern Ireland) 2001 (2), makes the following Order. In accordance with section 8A(5) of the Act the Department of Finance have consulted, where they think it appropriate, with the Treasury.

**Title and commencement** **N.I.**

1. This Order may be cited as the Government Resources and Accounts (Northern Ireland) Act 2001 (Estimates and Accounts) (Designation of Bodies) (Amendment) Order 2024 and shall come into operation on 8<sup>th</sup> February 2024.

### EXPLANATORY NOTE

*(This note is not part of the Regulations)*

This Order amends the Government Resources and Accounts (Northern Ireland) Act 2001 (Estimates and Accounts) (Designation of Bodies) Order 2023 ([S.I. 2023 No. 53](#)) (“the principal Order”), which designates specified central government bodies in relation to named government departments for the purpose of those departments’ supply estimates and resource accounts.

A new Schedule is substituted for the Schedule to the principal Order. The effect of this amendment is that one body has been removed.

The designations have effect for the financial year that ends on 31 March 2024.
