The Mesothelioma Lump Sum Payments (2023 Conditions and Amounts) (Amendment) Regulations (Northern Ireland) 2024

### Citation, commencement and application

- 1.—(1) These Regulations may be cited as the Mesothelioma Lump Sum Payments (2023 Conditions and Amounts) (Amendment) Regulations (Northern Ireland) 2024 and shall come into operation on 22nd March 2024.
  - (2) In regulation 2—
    - (a) paragraph (a) applies only in relation to a person—
      - (i) first diagnosed with diffuse mesothelioma on or after 1st April 2023; or
      - (ii) where the date of the first diagnosis with diffuse mesothelioma is unknown, if a claim under section 1(1) of the Mesothelioma, etc., Act (Northern Ireland) 2008 is made by that person on or after 1st April 2023; and
    - (b) paragraph (b) applies only in relation to the dependant of a person who dies on or after 1st April 2023 and who, immediately before death, had diffuse mesothelioma.

  - (b) for Table 2 substitute the Table set out in Part 2 of the Schedule to these Regulations.
