(b) he lost his employment through his misconduct, or

(c) he left his work voluntarily without just cause, shall not be regarded as genuinely seeking whole-time employment but unable to obtain such employment for an additional period equal to the length of the statutory disqualification : provided that the additional period of disqualification shall not be applicable if, in the opinion of the Committee an applicant has been engaged in bona-fide employment subsequent to the date of

the expiration of the period of the Statutory disgualification.

## Mercantile Marine.

THE UNEMPLOYMENT INSURANCE (MERCANTILE MARINE) SPECIAL ORDER (NORTHERN IRELAND), 1922, DATED 16TH JUNE, 1922, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND, UNDER THE UNEMPLOYMENT INSURANCE ACT, 1920 (10 & 11 GEO. 5, c. 30).

### 1922. No. 30.

Whereas by Section 39 of the Act of 1920 it is enacted that the Ministry of Labour for Northern Ireland may, after consultation with the Board of Trade, make a special order modifying, in such manner as the said Ministry thinks proper, the provisions of the Act of 1920 (other than provisions determining the rates of contributions), in their application to masters, seamen and apprentices to the sea service and sea fishing service ; and

Whereas by the Order of 1921, it is provided that any masters, seamen or apprentices who are neither domiciled nor have a place of residence in the United Kingdom, and any masters, seamen or apprentices who have neither been domiciled nor had a place of residence in the United Kingdom since the 8th day of November, 1920, shall be excluded from the Act of 1920, but that the employer of any such master, seaman or apprentice shall be liable to pay contributions at the same rate as would have been payable by him as employer's contributions if such master, seaman or apprentice had been an employed person within the meaning of the Act of 1920, except that no such contributions shall be payable in respect of a master, seaman or apprentice employed in a ship engaged in regular trade on foreign stations or over 70 years of age ; and

Whereas contributions paid by employers under the National Health Insurance Acts, 1911 to 1921, in respect of masters, seamen and apprentices who are neither domiciled nor have a place of residence in the United Kingdom are credited to a special fund (hereinafter referred to as the Special Fund) managed by a governing body constituted in pursuance of paragraph (c) of sub-section 1 of Section 27 of the Act of 1918 (hereinafter referred to as the Governing Body); and

Whereas by the last mentioned provision it is enacted that the Governing Body shall, subject to the approval of the Board of Trade and the National Health Insurance Joint Committee, prepare a scheme (hereinafter referred to as the Scheme) for the provision of benefits out of the sums credited to the Special Fund; and

Whereas it is expedient that the funds arising from contributions paid by employers under the order of 1921, and payable into the Northern Irish Unemployment Fund, should be administered in like manner with the funds arising from contributions paid by employers under the National Health Insurance Acts, 1911 to 1921, in respect of masters, seamen and apprentices who are neither domiciled nor have a place of residence in the United Kingdom,

Now, therefore, the Ministry of Labour for Northern Ireland in pursuance of Section 39 of the Act of 1920, after consultation with the Board of Trade, hereby makes the following Special Order :---

1. Contributions paid by employers under the Order of 1921, in respect of masters, seamen and apprentices to the sea service and sea fishing service, and payable under Article 4 (3) of the Government of Ireland (Adaptation of Unemployment Insurance Acts) Order, 1922, into the Northern Irish Unemployment Fund, shall be credited to the Special Fund and shall be applied by the Governing Body for the provision of such benefits specified in the scheme as may be approved by the Ministry of Labour for Northern Ireland and the Board of Trade.

- 2. In this Order, save where the context otherwise requires-
  - The expression "The Act of 1918" means the National Health Insurance Act, 1918, as that Act applies to Northern Ireland under and subject to the provisions of the Government of Ireland Act, 1920, and any order made by His Majesty in Council in pursuance of the last mentioned Act :—
  - The expression "the Act of 1920" means the Unemployment Insurance Act, 1920, as that Act applies to Northern Ireland under and subject to the aforesaid provisions :
  - The expression "the National Health Insurance Acts, 1911 to 1921", means those Acts as they apply to Northern Ireland under and subject to the aforesaid provisions :
  - The expression "the Order of 1921" means the Unemployment Insurance (Mercantile Marine) Special Order, 1921," as that Order applies to Northern Ireland under and subject to the aforesaid provisions.

Other expressions have the same meaning as in Section 48 in Part I of the National Insurance Act, 1911.

3. This Order may be cited as the Unemployment Insurance (Mercantile Marine) Special Order (Northern Ireland), 1922.
