The occupier of any such premises or place and any other person employing any employed contributor or employing any employed person, and the servants and agents of any such occupier or other person and any employed contributor or any employed person shall furnish to any inspector all such information and shall produce for inspection all such registers, books, cards, wages sheets, records of wages, and other documents as the inspector may reasonably require: Provided, that no one shall be required to answer any question or give any evidence tending to incriminate himself.

Arrest and Detention of Suspected Persons.

REGULATION DATED 20TH MAY, 1922, UNDER THE CIVIL AUTHORITIES (SPECIAL POWERS) ACT (NORTHERN IRELAND), 1922, PROVIDING FOR THE ARREST AND DETENTION OF SUSPECTED PERSONS.

1922. No. 34.

Whereas certain Regulations for Peace and Order in Northern Ireland are contained in the Schedule to the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, and it is provided by Sub-section (3) of Section 1 of the said Act that the Minister of Home Affairs shall have power to make Regulations—

- (a) for making further provision for the preservation of the Peace and Maintenance of Order; and
- (b) for varying or revoking any provision of the Regulations, whether contained in the said Schedule or made as aforesaid.

And that any Regulations made as aforesaid shall, subject to the provisions of the said Act, have effect and be enforced in like manner as regulations contained in the said Schedule:

Now, therefore, I, the Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, by this Regulation do make further provision for the Preservation of the Peace and Maintenance of Order, and do vary the provision of the regulation hereinafter mentioned as follows, that is to say—The second clause of Regulation 23 is hereby revoked and the following clause is substituted therefor, and the said regulation shall have effect and be construed accordingly:—

Any person so arrested may, on the order of the civil authority, be detained either in any of His Majesty's prisons or elsewhere, as may be specified in the Order, upon such conditions as the civil authority may direct, until he has been discharged by direction of the Attorney-General or is brought before a Court of Summary Jurisdiction. Any person to be brought before a Court under this regulation shall receive at least twenty-four hours notice in writing of the nature of the charge preferred against him.
