

Physical Training :

38. The Diploma of any institution recognised for the purpose by the Ministry.

Specially qualified persons will always be exceptionally recognised ; but such recognition will be granted only when the applicant for recognition has satisfied the Ministry that he is specially qualified. Application for such recognition should be accompanied by a complete detailed statement of the applicant's course of study and work ; and should be supported, as far as possible, by certificates from professors or employers. In order to determine finally whether a teacher has sufficient technical knowledge of the subject which he seeks to teach the Ministry may require him to undergo a special examination. Such examination will, as a rule, be held in Belfast ; and the applicant will have to bear his own travelling and personal expenses in connection therewith.

Registration of a teacher's qualifications may be suspended (or further provisional recognition refused) upon evidence of insufficient knowledge of a subject for teaching purposes, or of inefficiency as a teacher from whatever cause.

The provisional recognition accorded a teacher by the Ministry in any subject will be confirmed when he has taught a class in that subject to the satisfaction of the Ministry, for at least two sessions.

Training College Grants.

MADE BY THE MINISTRY OF EDUCATION, NORTHERN IRELAND, IN ACCORDANCE WITH THE PROVISIONS OF THE EDUCATION ACT (NORTHERN IRELAND), 1923, AND PRESENTED TO BOTH HOUSES OF PARLIAMENT IN PURSUANCE OF SECTION 99 (2) OF THE ACT AFORESAID.

In pursuance of the powers conferred by the Education Act (Northern Ireland), 1923, the Ministry of Education for Northern Ireland (hereinafter referred to as "the Ministry") hereby makes the following Regulations :—

1. The Ministry shall pay to the Committee for the Training of Teachers for Northern Ireland, established by the Minister of Education by Minute dated 19th May, 1922 (hereinafter referred to as "the Committee"), in respect of each student undergoing training for the position of teacher in public elementary schools in Northern Ireland in Training Colleges under the control of the Committee, grants at such rates as may be fixed by the Ministry with the approval of the Ministry of Finance for Northern Ireland.

2. The Ministry shall defray such capital expenditure as is incurred by the Committee, with the approval of the Ministry and the Ministry of Finance, in providing and equipping a Training College and hostels or other accommodation for students, out of such moneys as are provided by Parliament for the purpose, or,

alternatively, may from the same source defray, in whole or in part, on such terms and conditions as may be approved by the Ministry of Finance, the annual loan charges in respect of capital expenditure incurred by any Training College under the control of the Committee.

3. The Ministry may hold all such examinations as it may decide to be necessary in connection with the training of students for the position of teacher in public elementary schools in Northern Ireland, including the examination of pupil teachers and monitors in their final years of service, and of candidates for recognition as junior assistant mistress, and may defray the cost of holding such examinations.

4. The Ministry may establish courses of instruction for teachers in any subjects of the school programmes, and may, with the approval of the Ministry of Finance, pay all necessary expenses incidental to the holding of the courses, including fees to lecturers and, where considered necessary by the Ministry, allowances towards the expenses necessarily incurred by teachers in attending the courses.

5. If, in the judgment of the Ministry, a teacher who completed his course of training prior to 1st February, 1922, at a Training College in receipt of grants from the Commissioners of National Education in Ireland, has, whilst serving in a public elementary school in Northern Ireland, fulfilled the conditions which would have entitled that Training College to receive a bonus under the Regulations of the said Commissioners in force immediately prior to 1st February, 1922, the Ministry, on receipt of an application from the Training College, may pay a bonus to the College at the appropriate rate specified in those Regulations.

6. If the Ministry is satisfied that the conditions for the payment of a grant to a college for the teaching of Irish, as set forth in the Regulations of the Commissioners of National Education in Ireland in force immediately before 1st February, 1922, have been fulfilled in respect of a teacher recognised in a public elementary school in Northern Ireland, the Ministry may make a grant to the college of the amount specified in section IV. of Schedule I. to the Regulations of the said Commissioners, provided that no payment shall be made by the Ministry in respect of the attendance of any teacher at a course which terminated after 1st February, 1922.

7. If the Ministry is satisfied that a teacher who, prior to 1st February, 1922, was awarded a prize for Irish by the Commissioners of National Education at the close of his final year of training, has, whilst serving in a public elementary school in Northern

Ireland, fulfilled the conditions which would have entitled him to a further grant under the terms of Schedule I. to the Rules and Regulations of the said Commissioners in force immediately prior to the 1st February, 1922, the Ministry may allow to the teacher the further grant to which he would have been so entitled.

8. These regulations may be cited as the Public Elementary Education (Training College Grants) Regulations, 1924.

EGGS.—MARKETING OF

MADE BY THE MINISTRY OF AGRICULTURE BY VIRTUE AND IN EXERCISE OF THE POWER FOR THIS PURPOSE VESTED IN IT BY THE MARKETING OF EGGS ACT (NORTHERN IRELAND), 1924.

1924. No. 77.

I. SHORT TITLE.

1. These Rules may be cited as the Marketing of Eggs (Northern Ireland) Rules, 1924.

II. DEFINITIONS.

2. In these Rules unless the context shall require a different construction:—

- (1) The expression "Act" shall mean the Marketing of Eggs Act (Northern Ireland), 1924.
- (2) The expression "the Ministry" shall mean the Ministry of Agriculture for Northern Ireland.
- (3) The expression "eggs" shall mean eggs in shell of domestic fowl (hens and ducks).

III. APPLICATIONS FOR LICENCES.

An application for a licence to carry on business in Northern Ireland as a wholesale dealer in eggs shall be made in the form or to the effect stated in the First Schedule to these Rules, and the granting of a licence will be conditional upon the completion by the applicant of the undertaking set out on that form as respects compliance with the conditions of the Rules hereinafter contained.
