## COUNTY COUNCIL OFFICERS.

### Assistant County Surveyors.

MADE BY THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND UNDER SUB-SECTION 4 OF SECTION 83 OF THE LOCAL GOVERNMENT (IRELAND) ACT, 1898.

1925. No. 88.

1. No person shall after the date of this Order be qualified to be appointed to the office of assistant surveyor in any county in Northern Ireland unless—

(a) (i) he has a diploma or degree in Engineering from a recognised University or College of Science, or a Certificate from His Majesty's Civil Service Commissioners that he is qualified to act as a county surveyor or as a deputy for a county surveyor ;

or

(ii) he is an Associate Member of the Institution of Civil Engineers, or of the Institution of Civil Engineers of Ireland, or has a certificate of having passed the voluntary examination for candidates for surveyorships held by the Incorporated Association of Municipal and County Engineers ;

or

(iii) he holds the office of assistant surveyor in any county in Northern Ireland ;

or

(iv) he furnishes to the Ministry satisfactory evidence that he had satisfied the Local Government Board for Ireland of his qualifications for the appointment of assistant surveyor, in accordance with the provisions of Articles 4 or 6 (e) of the Order of the said Board dated the 31st March, 1913, with respect to the appointment of assistant surveyors in Ireland ;

(b) he produces satisfactory evidence to the Ministry that his health and character are good ;

(c) at the date of his appointment by the County Council he is not less than twenty-one years of age, nor more than forty-five years of age :

provided that the maximum age limit shall not apply to any applicant who holds the office of assistant surveyor in any County in Northern Ireland.

2. In any case where it is proposed to appoint a special assistant to the County Surveyor the Ministry may require the candidate to be possessed of such additional qualifications as may be deemed necessary, having regard to the special duties to be performed.

3. The Order made by the Local Government Board for Ireland on the 31st March, 1913, prescribing qualifications for assistant surveyors for Counties in Ireland, is, subject to the provisions of this Order hereby revoked.

4. This Order may be cited as "The Assistant Surveyors Qualifications Order (Northern Ireland) 1925."

#### PROHIBITION OF IMPORTATION OF POTATOES.

1. For the prevention of the introduction of the Colorado Beetle the landing in Northern Ireland of any potatoes grown in the Dominion of Canada is hereby prohibited.

#### COMMENCEMENT.

2. This Order shall come into operation on the twenty-fifth day of February, nineteen hundred and twenty-five.

#### SHORT TITLE.

This Order may be cited as the Colorado Beetle (Northern Ireland) Order of 1925.

In Witness whereof the Official Seal of the Ministry of Agriculture for Northern Ireland is hereunto affixed this Twenty-fifth day of February, nineteen hundred and twenty-five.
