Service Dependants Pensions.

MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE, AFTER CONSULTATION WITH THE ADMIRALTY, THE ARMY COUNCIL, THE AIR COUNCIL, AND THE MINISTER OF PENSIONS, AND IN CONJUNCTION WITH THE MINISTRY OF FINANCE UNDER PROVISO (I) TO SUB-SECTION (1) OF SECTION 24 OF THE WIDOWS', ORPHANS' AND OLD AGE CONTRIBUTORY PENSIONS ACT (NORTHERN IRELAND), 1925.

1926. No. 108.

The National Health Insurance Joint Committee, after consultation with the Admiralty, the Army Council, the Air Council and the Minister of Pensions, and acting in conjunction with the Service Dependants Pensions

Ministry of Finance, and in pursuance of the powers conferred on them by proviso (i) to subsection (1) of Section 24 of the Widows^{*}, Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1925, and of all other powers enabling them in that behalf, hereby make the following Regulations :---

1. These Regulations may be cited as the Contributory Pensions (Service Dependants Pensions) Regulations (Northern Ireland) 1926, and shall be deemed to have had effect as from and after 3rd January, 1926.

2.—(1) In these Regulations, unless the context otherwise requires—

"The Act" means the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1925.

"The Ministry" means the Ministry of Labour.

"The service pension authority" means the Admiralty, the Army Council, the Air Council, or the Minister of Pensions as the case may require.

(2) The Interpretation Act 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.

3. There shall be excluded from the provisions of subsection (1) of Section 24 of the Act (which subsection prohibits payment of pensions under the Act in cases where service dependants pensions are payable) the service dependants pensions set out in the Schedule to these Regulations, being service dependants pensions calculated with reference to the necessities of the pensioner, in these Regulations referred to as "scheduled pensions."

4. In any case in which the service pension authority has paid a scheduled pension to any person being a person not at the time in receipt of a pension under the Act and either—

- (a) such scheduled pension would not have been paid if the person had then been in receipt of a pension under the Act; or
- (b) such scheduled pension is in excess of the amount which would have been paid to that person if he had been in receipt of a pension under the Act;

the Ministry may, if a claim by that person for a pension under the Act in respect of any part of the period during which a scheduled pension has been so paid is subsequently allowed, treat the pension under the Act so allowed as reduced for the purposes of the Act by an amount not exceeding such an amount as the service pension authority certifies to have been so paid or so paid in excess, as the case may be, in respect of the period for which the pension under the Act was allowed, and the Ministry may pay to the service pension authority the amount by which the pension is treated as having been reduced as aforesaid, so, how-

ever, that the total amount to be so paid by the Ministry shall not exceed the amount of the pension under the Act in respect of the period aforesaid.

"NEEDS" SERVICE DEPENDANTS PENSIONS EXCLUDED FROM THE PROVISIONS OF SECTION 24 (1) OF THE ACT.

(a) Administered by the Admiralty.

(i) Allowances to the parents, brothers and sisters of deceased Officers, Nurses, Seamen and Marines awarded under Orders in Council, and

(ii) Certain of the allowances granted in respect of civilians under the Schemes framed under the Injuries in War (Compensation) Act, 1914, and the Injuries in War Compensation Act, 1914 (Session 2).

(b) Administered by the Army Council.

. Pensions awarded from Army Funds to the parents, brothers and sisters of deceased officers, nurses, warrant officers and soldiers under the provisions of the Royal Warrants for the Pay, etc., of the Army.

(c) Administered by the Air Council.

Allowances awarded to the dependent parents and brothers and sisters of deceased officers, nurses and airmen under the conditions laid down in the King's Regulations and Air Council Instructions for the Royal Air Force.

(d) Administered by the Ministry of Pensions.

Pensions in respect of Officers.

Pensions to the widows (including separated wives) of officers on second widowhood, and to the parents and other relatives of officers under Articles 15, 19, 21, .22A and 22B of—

- (1) the Royal Warrant (as amended) of 2nd July, 1920, as to retired pay, etc., of officers (Army), etc.,
- (2) the Order-in-Council (as amended) of 9th March, 1921, as to retired pay, etc., of naval officers, etc.,
- (3) the Order-in-Council (as amended) of 9th March, 1921, as to retired pay, etc., of naval warrant officers, etc., and
 - (4) the Royal Order (as amended) of 25th September, 1921, as to retired pay, etc., of officers (Air Force), etc.

Pensions in respect of Nurses.

Pensions to the parents and other relatives of nurses under Article 29_{Δ} of (1), (2) and (4) above.

Pensions in respect of Men.

Pensions to the parents and dependants of men under Articles 21 (1), 21A, 21B, and 22 of,

- (1) the Royal Warrant (as amended) of 6th December, 1919, as to the pensions of soldiers, etc.,
- (2) the Royal Order (as amended) of 11th May, 1920, as to the pensions of airmen, etc., and
- (3) the Order-in-Council (as amended) of 11th June, 1920, as to the pensions of seamen, etc.
