**Rates of Interest.**

---

MADE BY THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND, WITH THE APPROVAL OF THE MINISTRY OF FINANCE FOR NORTHERN IRELAND.

1927. No. 12.

The Ministry of Home Affairs for Northern Ireland in pursuance of the powers conferred on it by Section 5 of the Housing Act, 1921 (as applied to Ireland by Section 10 of the said Act) and by the Government of Ireland Act, 1920, and Adaptation Orders made thereunder and of all other powers thereto enabling the Ministry in this behalf, with the approval of the Ministry of Finance for Northern Ireland, hereby orders as follow :—

1. The rate of interest on advances made under Section 1 of the Small Dwellings Acquisition Act, 1899, and on expenses incurred by Local Authorities under Section 23 of the Housing (Ireland) Act, 1919, on or after the 1st day of February, 1927, shall be five and three-quarters per cent. per annum :

Provided that nothing in this Order shall affect the rate of interest on any advance made or expenses incurred or to be made or incurred in respect of contracts entered into or applications granted under the said Sections prior to the said date.

2. The provisions of this Order shall not apply to advances made or to be made by the Council of the County Borough of Belfast or Section 1 of the Small Dwellings Acquisition Act, 1899 .

3. Save as respects advances made or expenses incurred, or to be made or incurred in respect of contracts entered into or applications granted under the said Sections before the said date,

the Rates of Interest (Housing) Order, Northern Ireland, 1924, is hereby revoked.

4. This Order may be cited as the Rates of Interest (Housing) Order (Northern Ireland), 1927.

## INTOXICATING LIQUOR ACT.

### Rates of Charges for Licences.

---

DETERMINED BY THE MINISTRY OF FINANCE UNDER SECTION 3 OF THE INTOXICATING LIQUOR ACT (NORTHERN IRELAND), 1923, AS AMENDED BY THE INTOXICATING LIQUOR (FINANCE) ACT, (NORTHERN IRELAND), 1925, OF THE RATES AT WHICH CHARGES ARE TO BE IMPOSED IN RESPECT OF LICENCES FOR THE SALE OF INTOXICATING LIQUOR BY RETAIL.

1927. No. 92.

In pursuance of subsections (3) (b) and (4) of Section 3 of the Intoxicating Liquor Act (Northern Ireland) 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925, the Ministry of Finance hereby determines that the rates at which charges are to be levied in respect of all licences for the sale of intoxicating liquor by retail granted or renewed during the year ending 30th September, 1928, shall be eighty per cent. of the maximum rates of charge authorised by sub-section (1) of section 1 of the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925.
