- (c) time up to but not exceeding five hours spent by the Arbitrator in travelling from his headquarters to and from the place of the hearing, or to and from the land which is the subject of the proceedings, shall be treated as part of the hearing;
- (d) the minimum fee shall be £13 13s.

1. When a request is made by any person interested in a holding liable to be sold by or at the instance of the Ministry of Finance (hereinafter referred to as "the Ministry") under the provisions of sub-section (1) of Section 54 of the Irish Land Act, 1903, as modified and adapted under the provisions of the Government of Ireland Act, 1920, and of any Order made by His Majesty in Council under the last mentioned Act, to have a person nominated to be the proprietor of such holding, such request shall be in the form set out in the Schedule to these Rules and shall state the event upon the happening of which the holding became liable to be sold, the interest of the person making the request, the particulars of the claims of all other persons including creditors interested in the holding (in so far as such claims may not be entered upon the Register of Titles), the name, address and profession, trade, occupation or designation of each claimant, and the particulars of the relief sought, and shall be verified by the affidavit of the applicant.

2. Together with the request there shall be lodged with the Ministry a certified copy of the Folio of the Register of Titles upon which the title of the holding is entered, or the original Land Certificate relating to the holding, and copies of any Grant of Probate or of Letters of Administration or other Instrument referred to in the request.

3. The Ministry shall consider the request and may require public notice thereof to be given in such manner as to it may seem. fit.

4. Any objections to the proposed nomination which may be lodged with the Ministry within the time prescribed in such notice shall be considered by the Ministry, which may cause a public or other enquiry to be held in regard thereto.

5. The Ministry shall upon completion of its enquiries make such order as may appear to it expedient and just.

6. An Order made in pursuance of a request shall be made by Minute of the Ministry under the Official Seal thereof, attested by the signature of a Secretary or an Assistant Secretary, and a copy of such Order shall be transmitted to the Registrar of Titles.

The Ministry of Home Affairs for Northern Ireland in pursuance of the powers conferred on it by section 10 of the Local Government Act (Northern Ireland), 1923, as amended by section 2 (1) of the Local Government (Financial Provisions) Act (Northern Ireland), 1924, and section 10 of the Economy (Exchequer Relief) Act (Northern Ireland), 1926, and with the approval of the Ministry of Finance for Northern Ireland, hereby makes the following Regulations :—

1 These Regulations may be cited as the Local Authorities (Parliamentary Grants) Regulations, 1927.

2-(1) The Ministry of Home Affairs for Northern Ireland (hereinafter called the Ministry of Home Affairs) shall, from time to time as occasion may require, prepare and issue a certificate
