The Ministry of Finance, in pursuance of the powers conferred upon it by Sections one and two of the Rules Publication Act (Northern Ireland), 1925 (hereinafter referred to as "the Act"), and with the concurrence of the Lord Chief Justice of Northern Ireland and the Speakers of the Senate and the House of Commons of Northern Ireland as required by the Act, hereby makes the following Regulations:—

The Inspector-General of the Royal Ulster Constabulary, being an authority to which paragraph (f) of sub-section (2) of Section 2 of the Act applies, is hereby prescribed as a rule-making authority for the purposes of the Act in respect of any statutory rules of a public nature made by him in connection with the administration of civil Government.

In pursuance of the powers vested in us by the Superannuation (Prison Officers) Act, 1919, as that Act applies in Northern Ireland as well under and in pursuance of the provisions of the Government of Ireland Act, 1920, and the enactments amending the same, as under the provisions of the Superannuation Acts (Northern Ireland), 1921 to 1925, and of all other powers thereunto enabling us. We, The Lords Justices of Northern Ireland, with the approval of the Ministry of Finance, do hereby prescribe that the Superannuation Acts 1834 to 1914 shall, in their application to the following classes of officers employed in Prisons in Northern Ireland, have effect and be deemed as from the 1st day of December, 1921, to have had effect, subject to the modifications contained in and provided by the said Superannuation (Prison Officers) Act, 1919, namely:—

And We do hereby, with the same approval, revoke any prescription heretofore made under the said Act of 1919 and applicable in Northern Ireland, but without prejudice to the operation of any such prescription previously to the issue of these presents.

Civil Service of Northern Ireland.

MADE BY THE MINISTRY OF FINANCE OF NORTHERN IRELAND UNDER SECTION 1 OF THE SUPERANNUATION ACT, 1887 (AS THAT ACT APPLIES TO THE CIVIL SERVICE OF NORTHERN IRELAND) RELATIVE TO THE AWARD OF COMPENSATION FOR INJURY.

Whereas it is provided in effect by section nine of the Workmen's Compensation Act, 1906, that the Ministry of Finance may, by Warrant laid before the Parliament of Northern Ireland, modify, for the purposes of the Workmen's Compensation Acts (Northern Ireland) 1906 to 1923, its Warrant made under section one of the Superannuation Act, 1887, which Warrant, dated the 4th November, 1925, regulates the award of compensation to persons employed in the Civil Service of Northern Ireland who are injured in the discharge of their duty, or to the dependants of such persons:
