Practical Laundrywork.—Washing, drying and folding kitchen cloths and towels.

Doing up white clothes and woollens.

SECOND YEAR-

General.—Arrangement of daily and weekly work in small households; care of clothes and lamps. Simple treatment of cuts and burns. Laying a dinner table. Simple food values. General rules for bleaching, starching, drying, damping, and ironing clothes.

Practical Cookery.—Preparation of simple dishes to illustrate the primary methods of cooking. Preparation and serving of simple invalid dishes.

Practical Laundrywork.—Revision of First Year Course. Doing up prints, coloured articles and table linen.

THIRD YEAR-

General.—Expenditure of wages; keeping simple household accounts; arrangement of meals; thrift; order. Standard proportions used in simple cookery.

Practical Cookery.—Preparation of meals from dishes taught in the First and Second Year Courses; reheating cooked food; yeast bread; packing a workman's dinner.

Practical Laundrywork.—Revision of First and Second Year Courses. Doing up collars and cuffs; silk.

B-2 Year Course

Alternatively, the above instruction may be arranged as a 2 year course, extending over not less than 35 lessons in each year of the course.

Secondary Teachers.

REGULATIONS, DATED 25TH APRIL, 1928, MADE BY THE MINISTRY OF EDUCATION FOR NORTHERN IRELAND, UNDER SECTIONS 65, 69 AND 77 OF THE EDUCATION ACT (NORTHERN IRELAND), 1923 (13 & 14 Geo. 5, Ch. 21), AFTER CONSULTATION WITH THE MINISTRY OF FINANCE AND LAID BEFORE PARLIAMENT IN ACCORDANCE WITH THE PROVISIONS OF SECTION 99 (2) OF THE ACT AFORESAID.

- 1. These Regulations may be cited as the "Regulations for Secondary Teachers (Northern Ireland), 1926, Amending Regulations No. 3, 1928."
- 2. Sub-sections (a) and (b) of Regulation 24 of the Regulations for Secondary Teachers (Northern Ireland), 1926 (hereinafter called the "Principal Regulations"), are hereby repealed and the following substituted therefor:—
 - "(a) His approved full-time secondary service given after 31st July, 1922, in recognized schools in Northern Ireland, together with one-half of his other approved full-time secondary service.

- (b) The excess over five years of the sum of:—
 - (1) His approved full-time preparatory service given after 31st July, 1923, in recognized schools in Northern Ireland; and
 - (2) One-half of his other approved full-time preparatory service."
- 3. Sub-section (a) of Regulation 25 of the Principal Regulations is hereby repealed and the following substituted therefor:—
 - " (a) The sum of :--
 - (1) His approved full-time secondary service given after 31st July, 1922, in recognized schools in Northern Ireland.
 - (2) His approved full-time preparatory service given after 31st July, 1923, in recognized schools in Northern Ireland, and
 - (3) One-half of his other approved full-time service."
- 4. Regulation 26 of the Principal Regulations is hereby repealed and the following substituted therefor:—

"26. For the purposes of Regulations 24 and 25 hereof—

- (a) Approved full-time preparatory service shall be taken to include approved full-time service in a recognized public elementary school in Northern Ireland;
- (b) Approved full-time secondary service shall be taken to include approved full-time service in a recognized technical school or junior technical school in Northern Ireland;
- (c) Approved full-time service shall be taken to include one-half of corresponding approved part-time service of not less than ten hours a week."
- 5. Regulation 30 of the Principal Regulations is hereby repealed and the following substituted therefor:—
 - "30. In the calculation of full-time service which is not allowed to count in full for the purposes of Regulations 24 and 25 hereof:—
 - (a) A teacher shall be regarded as having given a year's service—
 - If he has been employed for a period of one year during which he has actually taught for at least thirty-five weeks;
 - (2) If he has been employed for broken periods of not less than a total of forty weeks of actual teaching, provided that no period of less than ten continuous weeks exclusive of vacations may be taken into account;
 - (b) Only complete quarter years calculated as set forth in Regulations 24 and 25 hereof may be taken into account:

- (c) Service in a University Institution may be specially considered, if it is certified by the University Authorities as full-time service;
- (d) Service which has been broken owing to exceptional causes may be specially considered:
- (e) The Ministry shall have power in exceptional circumstances to allow a modification of all or any of Regulations 24 to 30 inclusive of these Regulations where it is satisfied that their strict application would involve hardship to the teacher concerned."
- 6. Regulation 38 of the Principal Regulations is hereby repealed.
- 7. A teacher who is on the authorized staff on 1st August, 1928, and who would benefit by the operation of these Regulations were he replaced upon the salary scale, may be so replaced as from that date, provided that an increased rate of salary shall be payable to him by reason of his being so replaced only in respect of his service subsequent to 31st July, 1928.
- 8. These Amending Regulations shall take and have effect on and after 1st August, 1928, and shall thenceforth be construed with and as forming part of the Principal Regulations as amended by the Regulations for Secondary Teachers (Northern Ireland), 1926, Amending Regulations Nos. 1 and 2, 1927.

- 2. Paragraph (h) of Regulation 1 of the Regulations for Secondary Teachers (Northern Ireland), 1926 (hereinafter called the "Principal Regulations"), as amended by the Regulations for Secondary Teachers (Northern Ireland), 1926, Amending
