- (iii) Five representatives of employers and five representatives of workers who shall be selected from the area within the jurisdiction of the Committee.
- (b) No. 2 District Trade Committee-
  - (i) A Chairman, who shall be the appointed member for the time being of the Trade Board.
  - (ii) Two members of the Trade Board, one of whom shall represent employers and may be nominated by the representatives of employers on the Board, and one shall represent workers and may be nominated by the representatives of workers on the Board.
  - (iii) Six representatives of employers and six representatives of workers, who shall be selected from the area within the jurisdiction of the Committee.

4. The Secretary of the District Trade Committees shall be the Secretary for the time being of the Dressmaking and Women's Light Clothing Trade Board.

5. Any question as to the construction or interpretation of these Regulations shall, in the event of dispute, be referred to the Ministry for decision.

6. These Regulations may be cited as the Trade Boards (Northern Ireland) District Trade Committees (Dressmaking and Women's Light Clothing Trade) Regulations, 1928.

### Retail Bespoke Tailoring.

THE TRADE BOARDS (NORTHERN IRELAND) DISTRICT TRADE COMMITTEES (RETAIL BESPOKE TAILORING TRADE) REGU-LATIONS, 1928, DATED 15TH AUGUST, 1928, MADE BY THE MINISTRY OF LABOUR UNDER SECTION 18 OF THE TRADE BOARDS ACT (NORTHERN IRELAND), 1923 (13 AND 14 GEO 5, CH. 32).

#### 1928. No. 92.

The Ministry of Labour (in these Regulations referred to as "the Ministry"), in pursuance of powers conferred by Section 18 of

the Trade Boards Act (Northern Ireland), 1923, and of every other power the Ministry hereunto enabling, hereby makes the following Regulations :—

1. The Ministry may, after consultation with the Retail Bespoke Tailoring Trade Board (Northern Ireland), establish District Trade Committees for the Retail Bespoke Tailoring Trade in Northern Ireland in accordance with these Regulations.

2. The jurisdiction of the District Trade Committees shall extend over the following areas :---

- (a) No. 1 DISTRICT TRADE COMMITTEE—the district comprised within the Poor Law Union Areas of Ballycastle, Ballymoney, Coleraine and Limavady, together with that portion of the town of Cloughmills which is not within Ballymoney Poor Law Union Area.
- (b) No. 2 DISTRICT TRADE COMMITTEE—Northern Ireland, exclusive of the County Boroughs of the Cities of Belfast and Londonderry and the districts within the jurisdiction of the No. 1 Committee as set out in (a) above.

It shall not be competent for a Committee to deal with matters other than matters affecting the area within its jurisdiction.

3. The District Trade Committees shall consist of persons appointed by the Ministry as follows :---

(a) No 1 District Trade Committee —

- (i) A Chairman, who shall be the appointed member for the time being of the Trade Board.
- (ii) Two members of the Trade Board, one of whom shall represent employers and may be nominated by the representatives of employers on the Board, and one shall represent workers and may be nominated by the representatives of workers on the Board.
- (iii) Five representatives of employers and five representatives of workers who shall be selected from the area within the jurisdiction of the Committee.
- (b) No. 2 District Trade Committee-
  - (i) A Chairman, who shall be the appointed member for the time being of the Trade Board.
  - (ii) Two members of the Trade Board, one of whom shall represent employers and may be nominated by the representatives of employers on the Board, and one shall represent workers and may be nominated by the representatives of workers on the Board.
  - (iii) Six representatives of employers and six representatives of workers, who shall be selected from the area within the jurisdiction of the Committee.

### UNEMPLOYMENT INSURANCE.

4. The Secretary of the District Trade Committees shall be the Secretary for the time being of the Retail Bespoke Tailoring Trade Board.

5. Any question as to the construction or interpretation of these Regulations shall, in the event of dispute, be referred to the Ministry for decision.

6. These Regulations may be cited as the Trade Boards (Northern Ireland) District Trade Committees (Retail Bespoke Tailoring Trade) Regulations, 1928.

The Ministry of Labour for Northern Ireland (hereinafter referred to as "The Ministry") by virtue of the powers conferred on it by Section 17 of the Unemployment Insurance Act, 1920 (hereinafter referred to as "the Act") as adapted to Northern Ireland by the Government of Ireland (Adaptation of Unemployment Insurance Acts) Order, 1922, and amended by Section 9 of the Unemployment Insurance Act, (Northern Ireland) 1928, and of all other powers enabling it in that behalf, hereby makes • the following regulations :—
