PROVISIONAL SPECIAL ORDER, DATED 10TH DECEMBER, 1929, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE AND THE MINISTRY OF LABOUR FOR NORTHERN IRELAND, ACTING JOINTLY, UNDER SECTION 1 OF, AND PARAGRAPH (f) OF PART I OF THE FIRST SCHEDULE TO, THE NATIONAL HEALTH INSURANCE ACT, 1924 (14 AND 15 GEO. 5, c. 38).

The National Health Insurance Joint Committee and the Ministry of Labour for Northern Ireland, acting jointly, hereby certify under sub-section (7) of Section 94 of the National Health Insurance Act, 1924 (hereinafter referred to as "the Act"), as amended by Section 17 of the National Health Insurance Act, 1928 (hereinafter referred to as "the amending Act"), as applied to Northern Ireland by the National Health Insurance Act (Northern Ireland), 1928 and the National Health Insurance (Extension of Enactments) Order (Northern Ireland), 1928 (hereinafter referred to as "the Northern Ireland Act and Order"), that it is expedient that this Order should come into operation forthwith, and in pursuance of the powers conferred on them by Section 1 of, and paragraph (f) of Part I of the First Schedule to, the Act, as amended by Section 20 of the amending Act as applied to Northern Ireland by the Northern Ireland Act and Order, and of all other powers enabling them in that behalf, hereby make the following Order :—

1.—(1) This Order may be cited as the National Health Insurance (Contractors for Manual Labour) (Exclusion) Order (Northern Ireland), 1929, and shall be deemed to have effect as from the 1st January, 1929.

(2) The Interpretation Act, 1921, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

2. Employment as a contractor under a contract with any Local or Public Authority for the construction, maintenance, improvement or repair of roads or other public works shall be deemed not to be employment within the meaning of the Act unless the employed person is mainly dependent for his livelihood on his earnings from this class of employment.

The National Health Insurance Joint Committee and the Ministry of Labour for Northern Ireland, acting jointly, and in pursuance of the powers conferred on them by the National Health Insurance Acts, 1924 to 1928, and of all other powers enabling them in that behalf hereby make the following Regulations:—

1.—(1) These Regulations may be cited as the National Health Insurance (Deposit Contributors) Amendment Regulations (Northern Ireland), 1929, and shall be read as one with the National Health Insurance (Deposit Contributors) Regulations (Northern Ireland), 1927 and 1928, and these Regulations and the National Health Insurance (Deposit Contributors) Regulations (Northern Ireland), 1927 and 1928, may be cited together as the
