

Unemployment Insurance (No. 2) Act (Northern Ireland), 1924, and all other powers enabling it in that behalf, hereby makes the following Order :—

(1) The variations and amendments of the provisions of the Scheme contained in the Schedule to this Order shall have effect and be deemed to have had effect as from 19th April, 1929.

(2) This Order may be cited as the Unemployment Insurance (Insurance Industry Special Scheme) (Variation and Amendment) Order (Northern Ireland), 1929, and this Order and the Unemployment Insurance (Insurance Industry Special Scheme) Orders (Northern Ireland), 1921 to 1928, may be cited together as the Unemployment Insurance (Insurance Industry Special Scheme) Orders (Northern Ireland), 1921, to 1929 and shall be construed as one.

SCHEDULE.

(1) Clause 13 Part II (Transitional Provisions) of the Benefit Table forming part of the Scheme shall have effect as though in paragraph (2) :—

- (a) the words "twenty-four months" were substituted for the words "twelve months," and
- (b) the words "shall continue to be so treated throughout a period of three years" were substituted for the words "shall continue to be so treated throughout a period of two years."

**Insurance Year.**

THE UNEMPLOYMENT INSURANCE (INSURANCE YEAR) REGULATIONS (NORTHERN IRELAND), 1929, DATED 23RD MAY, 1929, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE UNEMPLOYMENT INSURANCE ACT, 1920 (10 AND 11 GEO. 5, c. 30).

The Ministry of Labour for Northern Ireland by virtue of the powers conferred on it by Sections 35 and 47 of the Unemployment Insurance Act, 1920, as adapted to Northern Ireland by the Government of Ireland (Adaptation of Unemployment Insurance

Acts) Order, 1922, and of all other powers enabling it in that behalf hereby makes the following regulations:—

1. The period commencing on the eighth day of July, 1929 (being the day next after the last day of the preceding Insurance Year) and ending on the sixth day of July, 1930, shall be an Insurance Year.
2. These Regulations may be cited as the Unemployment Insurance (Insurance Year) Regulations (Northern Ireland), 1929, and shall come into force on the date hereof.

### Mercantile Marine.

THE UNEMPLOYMENT INSURANCE (MERCANTILE MARINE) SPECIAL ORDER (NORTHERN IRELAND), 1929, DATED FEBRUARY 16TH, 1929, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE UNEMPLOYMENT INSURANCE ACT, 1920 (10 AND 11 GEO. 5, c. 30).

1929. No. 95.

The Ministry of Labour for Northern Ireland by virtue of the powers conferred on it by sections 37 and 39 of the Unemployment Insurance Act, 1920, as adapted to Northern Ireland by the Government of Ireland (Adaptation of Unemployment Insurance Acts) Order, 1922, and of all other powers enabling it in that behalf after consultation with the Board of Trade hereby makes the following Special Order:—

1. In proviso (b) to paragraph 1 of the Unemployment Insurance (Mercantile Marine) Special Order, 1921, for the words "over seventy years of age" there shall be substituted the words "over sixty-five years of age."
2. For paragraph 3 of the Unemployment Insurance (Mercantile Marine) Special Order, 1921, there shall be substituted the following paragraph:—  
"3. Save where the context otherwise requires, expressions in this Order have the same meaning as in section 132 of the National Health Insurance Act, 1924."

3. The Interpretation Act, 1921, shall apply to the interpretation of this Order and the Unemployment Insurance (Mercantile
