THE UNEMPLOYMENT INSURANCE (MERCANTILE MARINE) (NO. 2) SPECIAL ORDER (NORTHERN IRELAND), 1929, DATED FEBRUARY 16TH, 1929, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE UNEMPLOYMENT INSURANCE ACT, 1920 (10 AND 11 GEO. 5, c. 30).

Whereas the Ministry of Labour for Northern Ireland (hereinafter referred to as "the Ministry") made the Unemployment Insurance (Mercantile Marine) Special Order (Northern Ireland), 1922, and it is expedient to revoke the said Special Order.

And Whereas by the Unemployment Insurance (Mercantile Marine) Special Orders (Northern Ireland), 1921 and 1929, it is provided that any masters, seamen, or apprentices who are neither domiciled nor have a place of residence in the United Kingdom, and any masters, seamen or apprentices who have neither been domiciled nor had a place of residence in the United Kingdom since the 8th day of November, 1920, shall be excluded from the Unemployment Insurance Act, 1920, but that the employer of any such master, seamen, or apprentice shall be liable to pay contributions at the same rate as would have been payable by him as employer's contributions if such master, seaman or apprentice had been an employed person within the meaning of the Unemployment Insurance Act, 1920, except that no such contributions shall be payable in respect of a master, seaman or apprentice employed in a ship engaged in regular trade on foreign stations or over 65 years of age;

And Whereas contributions paid by employers under the National Health Insurance Acts (Northern Ireland), 1924 to 1928, and the National Health Insurance (Extension of Enactments) Order (Northern Ireland), 1928, in respect of masters, seamen and apprentices who are neither domiciled nor have a place of residence in the United Kingdom are subject to the provisions of the said Acts and Order credited to a special fund (hereinafter referred to as "the Seamen's Special Fund ") which Special Fund is vested in and administered by a body (hereinafter referred to as "the Governing Body") constituted in accordance with the provisions of the said Acts and Order.

And Whereas under the provisions of the said Acts and Order the Governing Body of the Seamen's Special Fund, subject to the approval of the Board of Trade and the National Health Insurance Joint Committee, have to prepare a scheme (hereinafter referred to as "the Scheme") for the provision of benefits out of the funds credited to the Seamen's Special Fund.

And Whereas it is expedient that the funds arising from contributions paid under the Unemployment Insurance (Mercantile Marine) Special Orders (Northern Ireland), 1921 and 1929, and payable into the Northern Irish Unemployment Fund, should be administered in like manner to the funds arising as aforesaid from contributions paid by employers under the National Health Insurance Acts (Northern Ireland), 1924 to 1928, and the National Health Insurance (Extension of Enactments) Order (Northern Ireland), 1928, in respect of masters, seamen, and apprentices who are neither domiciled nor have a place of residence in the United Kingdom.

Now therefore the Ministry by virtue of the powers conferred on it by sections 37 and 39 of the Unemployment Insurance Act, 1920, as adapted to Northern Ireland by the Government of Ireland (Adaptation of Unemployment Insurance Acts) Order, 1922, and of all other powers enabling it in that behalf after consultation with the Board of Trade hereby makes the following Special Order :---

1. The Unemployment Insurance (Mercantile Marine) Special Order (Northern Ireland), 1922, is hereby revoked, but such revocation shall not affect any right, privilege, obligation, or liability acquired, accrued, or incurred, or anything done or to be done under that Special Order.

2. Contributions paid by employers under the Unemployment Insurance (Mercantile Marine) Special Orders (Northern Ireland), 1921 and 1929, in respect of masters, seamen, and apprentices to the sea service and the sea fishing service, and payable under sub-clause (3) of clause 4 of the Government of Ireland (Adaptation of Unemployment Insurance Acts) Order, 1922, shall be credited to the Seamen's Special Fund and shall be applied by the Governing Body for the provision of such benefits specified Mèrcantile Marine : Collection of Contributions.

in the Scheme as may be approved by the Ministry and the Board of Trade.

3. Save where the context otherwise requires, expressions in this Order have the same meaning as in section 132 of tho . National Health Insurance Act, 1924.

4. The Interpretation Act, 1921, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

5.—(1) This Order may be cited as the Unemployment Insurance (Mercantile Marine) (No. 2) Special Order (Northern Ireland), 1929, and shall be included amongst the Orders that may be cited together as the Unemployment Insurance (Mercantile Marine) Special Orders (Northern Ireland), 1921 and 1929.

(2) This Order shall have effect as from the 25th day of February, 1929.
