AMENDMENT OF HOUSING GRANT RULES (NORTHERN IRELAND), 1930.

1930. No. 102.

The Ministry of Home Affairs for Northern Ireland in pursuance of the powers conferred on it by the Housing Acts (Northern Ireland), 1890 to 1930, and of all other powers thereto enabling it, hereby makes the following amendments in the Housing Grant Rules (Northern Ireland), 1930 :—

- 1. In Schedule I, paragraph 1, after (d) add the following :—
(e) In Rural Districts a certificate from the Medical Officer of Health of the district to the effect that he is satisfied that the proposed site is suitable for the erection of dwelling-houses, and that the proposed arrangements for sanitation and water supply are satisfactory. The Medical Officer of Health shall be entitled to a fee of ten shillings and sixpence for giving such certificate in respect of each site, whether one or more houses are to be erected thereon.

2. In Schedule 2, Part 1,—Planning: for the paragraph entitled “(a) Site,” substitute the following:—

(a) Site:—The site must be suitable for the building of dwelling-houses; be reasonably dry and free from any liability to flooding. In rural districts, the certificate mentioned in paragraph 1 (e) of Schedule 1 must be obtained from the Medical Officer of Health of the district. In all cases, prior to the issue of Certificate “A,” the Surveyor must satisfy himself that the site is in all respects a suitable one.

3. In Schedule 2, Part II,—Specifications: In the paragraph relating to brickwork delete the words “in exposed positions.”

HOUSING GRANT (AMENDMENT) RULES (NORTHERN IRELAND),
1930.

1930. No. 124.

WHEREAS the Ministry of Home Affairs for Northern Ireland in pursuance of the powers conferred on it by the Housing Acts (Northern Ireland) 1890-1930, and of all other powers thereto enabling it, on the 10th day of March, 1930, made Rules (hereinafter referred to as “the principal Rules”) prescribing the conditions under which grants might be paid to local authorities and private persons building houses under the Housing Acts:

And whereas by Article 3 of Order dated the 31st day of July, 1930, made in pursuance of the aforesaid powers the Ministry of Home Affairs directed that the specification relating to brickwork in Schedule 2 of Part II. of the principal Rules should be amended by deleting the words “in exposed positions”:

And whereas certain doubts have arisen as to the application of the principal Rules as so amended:

And whereas it is expedient to amend the said Order of the 31st day of July, 1930, in manner following:

Now, therefore, the Ministry of Home Affairs for Northern Ireland in pursuance of the aforesaid powers hereby makes the following Rules:—

1. Notwithstanding anything in the Principal Rules as amended by Article 3 of the Order of the Ministry of Home Affairs dated the 31st day of July, 1930, it shall not be necessary, and it shall be deemed never to have been necessary, to render in cement or finish rough-cast any wall faced with facing brick of good quality.

2. These Rules shall be cited as the Housing Grant (Amendment) Rules (Northern Ireland), 1930.
