THE UNEMPLOYMENT INSURANCE (PAYMENT OF TRAVELLING EXPENSES) REGULATIONS (NORTHERN IRELAND), 1930, DATED 9TH MAY, 1930, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND, UNDER THE UNEMPLOYMENT INSURANCE ACTS (NORTHERN IRELAND), 1920 TO 1930.

1930. No. 110.

The Ministry of Labour for Northern Ireland, by virtue of the powers conferred on it by Section 35 of the Unemployment Insurance Act, 1920, as adapted by the Government of Ireland (Adaptation of Unemployment Insurance Acts) Order, 1922, and of all other powers enabling it in that behalf and with the consent of the Ministry of Finance for Northern Ireland, hereby makes the following Regulations :—

1. Where any payment, whether by way of grant or advance, has, on or after the date from which these Regulations have effect, been made out of moneys provided by Parliament to, or in respect of any person, being an insured contributor in whose case the first statutory condition is fulfilled, on account of the expenses of travelling to any place for the purpose of obtaining employment whether employment has or has not been found for that person at that place, the amount which the Ministry may, under Section 12 of the Unemployment Insurance (Amendment) Act (Northern Ireland), 1930, repay out of the Unemployment Fund to the

Exchequer of Northern Ireland shall be one-half of the amount (if any) by which the said payment exceeds 4s.

2. The Unemployment Insurance (Payment of Travelling Expenses) Regulations (Northern Ireland), 1928, are hereby revoked but such revocation shall not affect any right, privilege, obligation or liability acquired, accrued or incurred under any of those Regulations.

3. In these Regulations the expressions "the Ministry," "Insured contributor," and "Unemployment Fund" have the same meanings as in the Unemployment Insurance Acts (Northern Ireland), 1920 to 1930.

4. These Regulations may be cited as the Unemployment Insurance (Payment of Travelling Expenses) Regulations (Northern Ireland), 1930, and shall have effect from and including the 13th day of March, 1930.

## WEEDS AND AGRICULTURAL SEEDS.

### Noxious Weeds.

THE NOXIOUS WEEDS ORDER (NORTHERN IRELAND), 1930,  
DATED 12TH MAY, 1930.

1930. No. 63.

The Ministry of Agriculture by virtue and in exercise of the power for this purpose vested in it by the Weeds and Agricultural Seeds Acts (Northern Ireland), 1909 and 1929, and of every other power in that behalf enabling it, hereby declares that throughout Northern Ireland all plants of the undermentioned species are, in addition to the plants of the species specified in the Noxious Weeds Order (Northern Ireland), 1929, noxious weeds for the purposes of the Weeds and Agricultural Seeds Acts (Northern Ireland), 1909 and 1929 :—

Ox-eye Daisy.

In Witness whereof the Official Seal of the Ministry of Agriculture, Northern Ireland, is hereunto affixed this twelfth day of May, nineteen hundred and thirty.
