HEALTH' INSURANCE -THE NATIONAL (JOINT COMMITTEE) (NORTHERN IRELAND). REGULATIONS DATED BY THE SEPTEMBER 1930. NATIONAL HEALTH MADE JOINT COMMITTEE UNDER THE NATIONAL INSURANCE HEALTH INSURANCE ACTS (NORTHERN IRELAND), 1924-1930.

1930. No. 126.

The National Health Insurance Joint Committee in pursuance of the powers conferred upon them by sub-Section (4) of Section 88 of the National Health Insurance Act, 1924, and of all other powers enabling them in that behalf hereby make the following Regulations:—

- 1. These Regulations may be cited as the National Health Insurance (Joint Committee) Regulations (Northern Ireland), 1930, and these Regulations and the National Health Insurance (Joint Committee) Regulations, 1924 to 1929 (in so far as those Regulations apply in Northern Ireland), may be cited together as the National Health Insurance (Joint Committee) Regulations (Northern Ireland), 1924 to 1930.
- 2.—(1) In these Regulations unless the context otherwise requires—the "Act of 1924" means the National Health Insurance Act, 1924, as that Act applies in Northern Ireland; the "Act of 1930" means the National Health Insurance Act (Northern Ireland), 1930; the "Joint Committee" means the National Health Iusurance Joint Committee; the "Ministry" means the Ministry of Labour for Northern Ireland.
- (2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.
- 3.—(1) For the purposes of the provisions of the Acts specified in the first column of the First Schedule to these Regulations, the Joint Committee alone shall exercise the powers specified in the third column of the said Schedule and set opposite to the provisions to which they respectively relate.
- (2) For the purposes of the provisions of the Acts specified in the first column of the Second Schedule to these Regulations, the Joint Committee shall exercise jointly with the Ministry the powers specified in the third column of the said Schedule and set opposite to the provisions to which they respectively relate.

Power to make Regulations providing that the expenses of a Sick Visiting Scheme framed or approved by the Ministry shall be treated as part of the administration expenses of Approved Societies in so far as they are not met by fees for specific visits made at the request of Societies.

REGULATIONS DATED THE 22ND DECEMBER, 1930, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE UNDER THE NATIONAL HEALTH INSURANCE ACTS (NORTHERN IRELAND), 1924 to 1928.

No. 174. 1930.

The National Health Insurance Joint Committee in pursuance of the powers conferred on them by the National Health Insurance Acts (Northern Ireland), 1924 to 1928, hereby make the following Regulations :—

- 1. These Regulations may be cited as the National Health Insurance (Joint Committee) Regulations (Northern Ireland) (No. 2), 1930.
- 2. Notwithstanding anything in the First Schedule to the National Health Insurance (Joint Committee) Regulations, 1929(a), the power to make Regulations providing for the transition of persons from the National Health Insurance Act, 1924(b), and the National Health Insurance (Prolongation of Insurance) Act, 1921(c), to the said Act of 1924, as amended by any subsequent enactment, shall as regards Northern Ireland be exercised solely by the Ministry of Labour for Northern Ireland, without prejudice, however, to the validity of any Regulations already made in pursuance of the Regulations first named in this Article.
