reason given by him for so dissenting, shall be recorded in the report of the proceedings of the Court.

6. In these Regulations the following expressions have the meanings hereby assigned to them respectively, that is to say—

"The Act" means the Unemployment Insurance Act, 1920, as amended by any subsequent enactment.

"Advisory Committee" means an advisory committee appointed under sub-section (5) of Section 2 of the Labour Exchanges Act, 1909.

"Court" means a Court of Referees for the purposes of the Act.

"Employers' Panel" and "Insured Contributors' Panel" mean the panels of persons chosen to represent employers and insured contributors respectively required to be constituted under sub-section (3) of Section 13 of the Act.

"The Ministry" means the Ministry of Labour for Northern Ireland.

7. The Unemployment Insurance (Courts of Referees) Regulations (Northern Ireland), 1928, are hereby revoked, but such revocation shall not affect any right, privilege, obligation or liability acquired, accrued or incurred under any of those Regulations.

8.—(1) These Regulations may be cited as the Unemployment Insurance (Courts of Referees) Regulations (Northern Ireland), 1930, and shall have effect and be deemed to have had effect from and including the 13th day of March, 1930.

(2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.

THE UNEMPLOYMENT INSURANCE (INSURANCE INDUSTRY SPECIAL SCHEME) (VARIATION AND AMENDMENT) SPECIAL ORDER (NORTHERN IRELAND) 1930, DATED 16TH JUNE, 1930, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE UNEMPLOYMENT INSURANCE ACT, 1920 (10 & 11 GEO. 5, c. 30).

Whereas the Ministry of Labour for Northern Ireland (hereinafter referred to as "the Ministry," by the Unemployment

### UNEMPLOYMENT INSURANCE

Insurance (Insurance Industry Special Scheme) Orders (Northern Ireland), 1921 to 1929 approved for the purposes of Section 18 of the Unemployment Insurance Act, 1920, a Special Scheme for the Insurance Industry and subsequently varied and amended the same and the same as so varied and amended is hereinafter referred to as "the Scheme."

And whereas application has been made to the Ministry for the further variation and amendment of the provisions of the Scheme.

Now therefore the Ministry by virtue of the powers conferred on it by the said Section 18, and all other powers enabling it in that behalf, hereby makes the following Special Order :—

(1) The variations and amendments of the provisions of the Scheme contained in the Schedule to this Order shall have effect except as otherwise expressly provided therein as from the 13th March, 1930.

(2) This Order may be cited as the Unemployment Insurance (Insurance Industry Special Scheme) (Variation and Amendment) Special Order (Northern Ireland), 1930, and this Order and the Unemployment Insurance (Insurance Industry Special Scheme) Orders (Northern Ireland), 1921 to 1929, may be cited together as the Unemployment Insurance (Insurance Industry Special Scheme) Orders (Northern Ireland), 1921 to 1930, and shall be contrued as one.

#### - SCHEDULE.

(1) In Part I.A. (Rates of Benefit) of the Benefit Table,

- (i) there were inserted after the words " benefit shall " the words " as from the 13th March, 1930 ";
- (ii) there were substituted for the words "twenty five shillings " the words " "twenty six shillings ";
- (iii) there were substituted for the words "twenty three shillings" the words "twenty four shillings."
- (2 In Part I.B. (Duration of Benefit) of the Benefit Table,
  - (i) there were inserted after the words "benefit shall" the words "as from the 1st November, 1929";
  - (ii) there were substituted for the words "not exceeding eighty four weeks and falling within a period of two years calculated from the date of the application in the prescribed manner for benefit in respect of such continuous period of unemployment" the words "so long as the conditions set out in Part II continue to be fulfilled."

- (3) In Part II (Transitional Provisions) of the Benefit Table-
  - (i) the words "thirty six months" were substituted for the words "twenty four months";
  - (ii) there were inserted at the end of sub-paragraph (c) of paragraph (2) the' words "but so that this sub-paragraph shall not have effect until the first day of July, 1933 ";
  - (iii) the words "shall continue to be so treated throughout a period of four years" were substituted for the words "shall continue to be so treated throughout a period of three years."

This Order having lain before both Houses of Parliament for 10 days in accordance with Section 4 (1) of the Rules Publication Act (Northern Ireland), 1925, duly came into force.

THE UNEMPLOYMENT INSURANCE (INSURANCE YEAR) REGULA-TIONS (NORTHERN IRELAND), 1930, DATED 5TH JULY, 1930, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE UNEMPLOYMENT INSURANCE ACT, 1920 (10 AND 11 GEO. 5, c. 30).

## 1930. No. 111.

The Ministry of Labour for Northern Ireland by virtue of the powers conferred on it by Sections 35 and 47 of the Unemployment Insurance Act, 1920, as adapted to Northern Ireland by the Government of Ireland (Adaptation of Unemployment Insurance Acts) Order, 1922, and of all other powers enabling it in that behalf hereby makes the following regulations :—

1. The period commencing on the seventh day of July, 1930, (being the day next after the last day of the preceding Insurance Year) and ending on the fifth day of July, 1931, shall be an Insurance Year.

2. These Regulations may be cited as the Unemployment Insurance (Insurance Year) Regulations (Northern Ireland), 1930 and shall come into force on the date hereof.
