1. So much of the Third Schedule to the Principal Order as sets out Section 24 of the Ballot Act, 1872 with adaptations and alterations for the purpose of elections of urban district councillors and town commissioners is hereby revoked.

2. This Order may be cited as the Urban District Councillors and Town Commissioners (Northern Ireland) Election Order, 1930, and shall be construed as one with the Principal Order as amended and applied as aforesaid.

Public Bodies.

THE PUBLIC BODIES ORDER, 1930.

1930. No. 83.

The Ministry of Home Affairs for Northern Ireland in exercise of the powers vested in it by the Local Government Acts (Northern Ireland), 1898 to 1929, and of all other powers in this behalf enabling the Ministry hereby orders and directs as follows, that is to say :---

(1) The following paragraph shall be added to and be read with Article 19 of the Public Bodies Order, 1904 :---

"Where the amount fixed as the normal balance exceeds the sum of Fifty Pounds, an account in the name of the council shall be opened with the treasurer, and the secretary or clerk shall lodge the paying order to be drawn by him as aforesaid to the credit of the account. As soon as the account has been opened, the secretary or clerk shall lodge.

"to the credit of the account any moneys which he has in hands for the purpose of making payments in respect of petty disbursements as aforesaid. Authority shall be given to the Secretary or clerk to draw on this account by cheque whenever he requires money for the purpose of making any payments in respect of petty disbursements as aforesaid."

(2) This Order may be cited as the Public Bodies Order, 1930, and shall be construed as one with the Public Bodies Order, 1904.

WHEREAS it is enacted by section 1 of the Criminal Lunatics Act (Northern Ireland), 1929, that the part of the Londonderry Prison specified in the Schedule to the said Act shall be the Criminal Lunatic Asylum for Northern Ireland, and is in the said Act referred to as "the Criminal Lunatic Asylum, Northern Ireland";

And whereas by section 7 of the Criminal Lunatics Act (Northern Ireland), 1929, it is enacted that the Governor of Northern Ireland may, by order in the Privy Council of Northern Ireland from time to time, amongst other things, make any rules which might appear to him to be necessary or proper for the good conduct and management of the Criminal Lunatic Asylum, Northern Ireland :

Now, therefore, the Governor of Northern Ireland, by and with the advice and consent of the Privy Council of Northern Ireland, by virtue and in pursuance of the powers vested in him for that purpose by the Criminal Lunatics Act (Northern Ireland), 1929, and of all other powers enabling him, does hereby make the following rules, as rules which appear to him to be necessary or proper for the good conduct and management of the Criminal Lunatic Asylum, Northern Ireland :---
