

with all such particulars as may be reasonably required as to the name or the composition of the disinfectant used.

(5) If any disinfectant which is not approved by the Ministry is falsely marked with a statement or indication that it has been so approved, or if any disinfectant purporting to be an approved disinfectant is not marked with a label as required by this Order the manufacturer and the retailer or other person selling the disinfectant, and the person who shall have so marked the disinfectant or caused the same to be so marked, or who shall use the disinfectant knowing the same to have been falsely marked, or omitting so to mark the disinfectant as the case may be, shall be deemed guilty of an offence against the Act of 1894.

*Commencement.*

2. This Order shall come into operation on the first day of May, nineteen hundred and thirty-one.

*Short Title.*

3. This Order may be cited as the Animals Disinfection (Northern Ireland) Order, 1927, Amendment Order, 1931.

**THE BOVINE TUBERCULOSIS (NORTHERN IRELAND) ORDER, 1926,  
AMENDMENT ORDER, 1931, DATED 3RD NOVEMBER, 1931.**

1931. No. 122.

The Ministry of Agriculture for Northern Ireland by virtue and in exercise of the powers vested in it under the Diseases of Animals Act, 1894, as amended and adapted by any subsequent enactments and of every other power enabling it in that behalf, orders and it is hereby ordered as follows :—

*Compensation.*

1. The Bovine Tuberculosis (Northern Ireland) Order, 1926, shall be read and have effect as if in paragraphs (2) and (3) of Article 10 the words "thirty shillings" were substituted for the words "forty-five shillings" wherever they occur.

*Commencement.*

2. This Order shall come into operation on the 1st day of December, nineteen hundred and thirty-one.

*Short Title.*

3. This Order may be cited as the Bovine Tuberculosis (Northern Ireland) Order, 1926, Amendment Order, 1931.

**Foreign Animals.**

THE FOREIGN ANIMALS (NORTHERN IRELAND) ORDER OF 1931,  
DATED 9TH JUNE, 1931.

1931. No. 58.

The Ministry of Agriculture for Northern Ireland by virtue and in exercise of the powers vested in it under the Diseases of Animals Act, 1894, as amended and adapted by any subsequent enactments and of every other power enabling it in that behalf, orders and it is hereby ordered as follows :—

*Prohibition of the Bringing of Animals into a Port in  
Northern Ireland from the Union of South Africa.*

1. The Foreign Animals (Northern Ireland) Order of 1928 shall be read and have effect as if the Union of South Africa were excluded from the schedule to that Order.

*Commencement.*

2. This Order shall come into operation as from the date thereof.
