

2. The following Article shall be substituted for Article 13 of the Principal Regulations :—

13. Members of the Council appointed under Part 3 of these Regulations shall, subject to the provisions of Article 16, hold office for a period of three years from the first day of October in the year of their appointment :

Provided that a person (other than a person nominated under the provisions of Article 10) being on 29th September, 1931, a member of the Council, or a person nominated under the provisions of Article 10 after 30th September, 1931, shall, subject to the provisions of Article 16, continue to hold office until 30th September, 1933.

3. These Regulations shall be deemed to have had effect from the 29th day of September, 1931.

### Reserve and Transfer Values.

REGULATIONS, DATED 11TH MARCH, 1931, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE UNDER THE NATIONAL HEALTH INSURANCE ACTS (NORTHERN IRELAND), 1924 TO 1930.

1931. No. 145.

The National Health Insurance Joint Committee, in exercise of the several powers conferred on them by the National Health Insurance Acts (Northern Ireland), 1924 to 1930, and of all other powers enabling them in that behalf, hereby make the following Regulations :—

1.—(1) These Regulations may be cited as the National Health Insurance (Reserve and Transfer Values) Amendment Regulations (Northern Ireland), 1931, and shall be read as one with the National Health Insurance (Reserve and Transfer Values) Regulations, 1928,<sup>(a)</sup> hereinafter referred to as “the principal Regulations.”

(2) These Regulations shall be deemed to have had effect as from the first day of October, 1930.

2. Article 11 of the principal Regulations shall be read and have effect as if the words "or, in Northern Ireland, of sanatorium benefit" were deleted therefrom.

3. Article 15 of the principal Regulations shall be read and have effect as if the words "or the Ministry of Labour for Northern Ireland" were inserted after the words "Insurance Committees," and as if the words "or (in the case of Northern Ireland) of sanatorium benefit" were deleted therefrom.

4. The words "medical benefit" shall be substituted for the words "the benefit" where they first occur in Tables I, II and III of the Fourth Schedule to the principal Regulations; and the words "medical or sanatorium benefit" shall be substituted for the words "the benefit" where they secondly occur in Tables I and III, and for the word "benefit" where it secondly occurs in Table II of the said Schedule.

### Subsidiary Employments.

SPECIAL ORDER, DATED 17TH OCTOBER, 1931, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE AND THE MINISTRY OF LABOUR FOR NORTHERN IRELAND, ACTING JOINTLY, UNDER PARAGRAPH (m) OF PART II OF THE FIRST SCHEDULE TO THE NATIONAL HEALTH INSURANCE ACT, 1924 (14 & 15 GEO. 5, C. 38), AND BY THE SAID JOINT COMMITTEE ACTING ALONE UNDER THE PROVISO TO SECTION 1 (2) OF THE SAID ACT.

The National Health Insurance Joint Committee and the Ministry of Labour for Northern Ireland, acting jointly, in pursuance of the powers conferred on them by paragraph (m) of Part II of the First Schedule to the National Health Insurance Act, 1924 (hereinafter referred to as "the Act"), and of all other powers enabling them in that behalf, and the said Joint Committee, in pursuance of the powers conferred on them by the proviso to sub-section (2) of Section 1 of the Act, and of all other powers enabling them in that behalf, and with the approval of the Ministry of Finance, hereby order as follows:—

1. The employments of the several classes set forth in the First Schedule hereto, are specified as being of such a nature that they are ordinarily adopted as subsidiary employments only and not as the principal means of livelihood.
