

**EGGS : MARKETING OF.**

THE MARKETING OF EGGS (AMENDMENT) RULES (NORTHERN IRELAND), 1932, DATED 27TH FEBRUARY, 1932.

1932. No. 18.

The Ministry of Agriculture for Northern Ireland in the exercise of the powers conferred on it by the Marketing of Eggs Acts (Northern Ireland), 1924 to 1931, and of any other power in that behalf enabling it hereby makes the following Rules, that is to say :—

1. *Short Title.*

These Rules may be cited as the Marketing of Eggs (Amendment) Rules (Northern Ireland), 1932.

2. *Records and Returns.*

The holder of a Class A. licence shall keep a record, on the form or to the effect prescribed in the schedule to these Rules, showing in respect of each consignment of eggs despatched to Great Britain, the Irish Free State, or the Isle of Man, the particulars set out on the said form.

3. *Revocation of Previous Rules.*

Paragraph 1 of Article VII (Records and Returns) of the Marketing of Eggs Rules (Northern Ireland), 1931, (Statutory Rules and Orders of Northern Ireland, Number 91, of 1931) is hereby revoked, but such revocation shall not :—

- (a) Affect the previous operation of those Rules, or anything duly done or suffered thereunder ; or
- (b) Affect any right, privilege, obligation, or liability acquired, accrued, or incurred thereunder ; or
- (c) Affect any penalty incurred in respect of any offence committed against these Rules ; or
- (d) Affect any investigation, legal proceeding, or remedy in respect of any such right, privilege, liability or penalty as aforesaid ; and any such investigation, legal proceeding, or remedy may be instituted, continued, or enforced, and any such penalty may be imposed, as if these Rules had not been made.

4. *Commencement.*

These Rules shall come into operation on the first day of March, 1932.

5. *General.*

The Ministry may from time to time rescind, amend, or vary these Rules, or any of them as occasion may require.
