THE SANITARY SUB-OFFICERS APPOINTMENTS (AMENDMENT) ORDER (NORTHERN IRELAND), 1933, DATED THE 6TH DECEMBER, 1933.

1933. No. 121.

WHEREAS by sub-section (3) of section 85 of the Local Government (Ireland) Act, 1898, it is enacted that the Local Government Board may make rules as to the employment of the same officers by a council of a rural district and the guardians of the union comprising that district :

And whereas by virtue of the Government of Ireland Act, 1920, and the Orders made thereunder, the aforesaid powers of the Local Government Board are now, as respects Northern Ireland, vested in the Ministry of Home Affairs for Northern Ireland :

Now, therefore, the Ministry of Home Affairs for Northern Ireland, in exercise of its powers under sub-section (3) of section 85 of the Local Government (Ireland) Act, 1898, and of all other statutes in this behalf enabling the Ministry hereby prescribes with respect to the appointment of Relieving Officers by Boards of Guardians, and of Sanitary Sub-Officers or of Inspectors of Dairies under the Dairies, Cowsheds and Milkshops Order, 1908, or of Collector of Rents of Labourers' Cottages, by Rural District Councils, as follows, that is to say :—

1. Notwithstanding anything contained in Article 4 or Article 5 of the Sanitary Order No. 1, dated 3rd May, 1900, where a vacancy occurs in a rural district in respect of the office of sanitary subofficer or of inspector of dairies under the Dairies, Cowsheds and Milkshops Order, 1908, or of collector of rents of labourers' cottages, such vacancy shall be filled and the duties of the office discharged by the person who for the time being holds the office of relieving officer for that portion of the union which comprises the portion of a rural district for which the sanitary sub-officer is required, except where the Ministry authorises the Council of a rural district situated in the union to appoint a separate sanitary sub-officer. In the event of there being at the time of such vacancy no relieving officer as aforesaid the person who is appointed by the Board of Guardians to the post of relieving officer shall be also the sanitary sub-officer.

2. No person shall be appointed to the office of relieving officer in the union unless the Ministry of Home Affairs is satisfied that his qualifications are such as to ensure his being able to discharge efficiently the duties of sanitary sub-officer.

3. If for any reason whatsoever the person holding the office of relieving officer for that portion of the union which comprises the portion of a rural district for which such person is also sanitary sub-officer at any time ceases to occupy either of such offices, such person shall thereupon vacate the offices of sanitary

sub-officer, inspector of dairies or collector of rents of labourers' cottages or of relieving officer, as the case may be.

4. The council of a rural district shall pay to the sanitary sub-officer such salary as may be approved by the Ministry.

5. The Ministry may, if it thinks fit, dispense with any of the conditions specified in Articles 1, 2 and 3 of this Order.

6. This Order may be cited as the Sanitary Sub-Officers Appointments (Amendment) Order (Northern Ireland), 1933.

7. The Order made by the Ministry on the 4th day of May, 1933, relating to the appointment of sanitary sub-officers is hereby revoked.

Tuberculosis : Procedure of Committees.

THE TUBERCULOSIS (PROCEDURE OF COMMITTEES) ORDER, 1933, DATED THE 25TH APRIL, 1933.

1933. No. 50.

WHEREAS it is enacted by Section five of the Tuberculosis Prevention (Ireland) Act, 1908, that every hospital or dispensary established by a county council under the said Act shall be managed by a Committee of Management appointed by the Council and that the Local Government Board for Ireland may by Order regulate the procedure of committees of management and make provision for the filling of casual vacancies in such committees including any such vacancy caused by a member of the Council :

And whereas the Local Government Board for Ireland duly made regulations in pursuance of the aforesaid provisions entitled the Tuberculosis (Procedure of Committees) Order, 1913, (hereinafter referred to as the principal Order) :

And whereas it is expedient to amend the said Order in manner hereinafter appearing :

And whereas the aforesaid functions of the said Local Government Board are transferred as respects Northern Ireland to the Ministry of Home Affairs for Northern Ireland :

Now, therefore, the Ministry of Home Affairs for Northern Ireland by virtue of the powers vested in the Ministry by the Tuberculosis Prevention (Ireland) Act, 1908, and of all other
