Ministry shall make such adjustments as may seem to it proper.

- 4. For the purpose of these regulations the expression "education authority" includes the Council of an urban county district which is making separate provision by virtue of the provisions of Part IV. of the Act for technical instruction in that district in accordance with a financial scheme approved by the Ministry.
- 5. The grants payable under Regulation (3) shall be paid by the Ministry in such portions and at such times as the Ministry may think proper.
- 6. These Regulations shall only apply to grants payable in respect of the financial year ending 31st March, 1935.
- 7. In the case of doubt or dispute as to the meaning and effect of any of these Regulations, the decision of the Ministry thereon shall be final.
- 8. These Regulations may be cited as the Parliamentary Grant (Education Authorities) Regulations, 1934-35.

REGULATIONS, DATED 8TH DAY OF JUNE, 1933, MADE BY THE MINISTRY OF EDUCATION, NORTHERN IRELAND, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE, NORTHERN IRELAND, IN ACCORDANCE WITH THE PROVISIONS OF THE EDUCATION ACTS (NORTHERN IRELAND), 1923 TO 1931, AND PRESENTED TO BOTH HOUSES OF PARLIAMENT IN PURSUANCE OF SECTION 99 (2) OF THE SAID EDUCATION ACT OF 1923.

In pursuance of the powers conferred by the Education Act (Northern Ireland), 1923 (hereinafter referred to as "the Act"), the Ministry of Education for Northern Ireland (hereinafter referred to as "the Ministry") after consultation with the Ministry

of Finance for Northern Ireland, hereby makes the following regulations in regard to the payment by the Ministry of grants or instruction of public elementary school pupils in extra and special subjects.

- 1. From and after the 30th day of June, 1933, section 6 of the Regulations for Instruction of Public Elementary School Pupils in Extra and Special Subjects, 1932 (Statutory Rules and Orders, 1932, No. 113) shall be amended by omitting therefrom the words—"3. Irish .. 9s. .. 45" in the last line of the section from which date the said words shall cease to operate or have effect; Provided, however, that the Ministry shall have power to pay grants as in the said section provided for instruction in Irish given in accordance with the said Regulations during the year ending on the 30th day of June, 1933.
- 2. These Regulations may be cited as the Amending Regulations for Instruction of Public Elementary School Pupils in Extra and Special Subjects, No. 1, 1933.

The Regulations for Staffing Public Elementary Schools, Northern Ireland, 1928 (Statutory Rules and Orders of Northern Ireland, 1928, No. 41) as amended by the Regulations for Staffing Public Elementary Schools (Northern Ireland) 1928, Amending Regulations No. 1, 1929, Amending Regulations No. 2, 1930, and Amending Regulations No. 3, 1930 (Statutory Rules and Orders of Northern Ireland, 1929, No. 162; 1930, No. 62; and 1930, No. 146 respectively) which Regulations as so amended are herein referred to as "The Principal Regulations" are hereby amended by the addition of the following regulations:—

1. For the purpose of these Regulations—

(a) A "large school" is defined to be a public elementary school, other than one conducted by members of religious communities and paid by capitation grant,
