Disposal of Balances.

REGULATIONS, DATED 22ND MAY, 1933, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND WITH THE CONSENT OF THE MINISTRY OF FINANCE UNDER THE NATIONAL HEALTH INSURANCE ACTS (NORTHERN IRELAND), 1924 TO 1932.

1933. No. 66.

The Ministry of Labour for Northern Ireland in pursuance of the powers conferred on it by Section 17 of the National Health Insurance Act (Northern Ireland) 1930, and with the consent of the Ministry of Finance hereby makes the following Regulations:—

1. These Regulations may be cited as the National Health Insurance (Disposal of Balances) Amendment Regulations (Northern Ireland), 1933, and shall be read as one with the National Health Insurance (Disposal of Balances) Regulations (Northern Ireland) 1932, hereinafter referred to as "the principal Regulations."

2. Article 8 of the principal Regulations shall be read and have effect as if the following words were inserted after the word "benefit" in the third line of the said Article:—

"and of a scheme approved by the Ministry under Section 9 of the Act of 1930."

REGULATIONS, DATED 20TH OCTOBER, 1933, MADE BY THE
MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER
THE NATIONAL HEALTH INSURANCE ACTS (NORTHERN
IRELAND), 1924 TO 1932.

1933. No. 111.

The Ministry of Labour for Northern Ireland in exercise of the powers conferred on it by Section 53 of the National Health Insurance Act, 1924, as amended and applied by the National Health Insurance Act (Northern Ireland), 1930 and of all other powers enabling it in that behalf, hereby makes the following Regulations :—

1. These Regulations may be cited as the National Health Insurance (Insurance Practitioners and Pharmaceutical Committees) Amendment Regulations (Northern Ireland), 1933, and shall be read as one with the National Health Insurance (Insurance Practitioners' and Pharmaceutical Committees) Regulations (Northern Ireland) 1930, hereinafter referred to as "the Principal Regulations."

2. The following Article shall be substituted for Article 4 of the Principal Regulations :—

" 4. A Local Insurance Practitioners' Committee shall be constituted for each of the areas set out in the Schedule to these Regulations, and a Local Pharmaceutical Committee shall be constituted for the whole area of Northern Ireland."

3. The following Article shall be substituted for Article 11 of the Principal Regulations :—

" 11. The provisions of Part 2 of these Regulations shall apply with the necessary modifications to the appointment of the Local Pharmaceutical Committee.

Provided that the number of persons to be appointed to the Local Pharmaceutical Committee shall be sixteen."

4. The following Article shall be substituted for Article 12 of the Principal Regulations :—
