# REGISTRATION OF BIRTHS, DEATHS AND MARRIAGES.

## Certificates.

THE CERTIFICATES OF BIRTHS, DEATHS AND MARRIAGES (REQUISITION) REGULATIONS (NORTHERN IRELAND), 1934, DATED 4TH DECEMBER, 1934, MADE BY THE MINISTRY OF FINANCE.

### 1934. No. 110.

The Ministry of Finance for Northern Ireland, in exercise of the powers conferred upon it by the following enactments as the same apply in Northern Ireland, namely:—

Section 10 of the Savings Banks Act, 1887;

Section 134 of the Factory and Workshop Act, 1901;

Section 32 of the Unemployment Insurance Act, 1920;

Section 101 of the National Health Insurance Act, 1924;

Section 31 of the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1925;

Section 45 of the Unemployment Assistance Act (Northern Ireland), 1934;

Section 3 of the Exchequer and Financial Provisions Act (Northern Ireland), 1934;

hereby makes the following Regulations:-

- 1. The requisition to be made to entitle any person to obtain a certificate or certified copy of an entry of birth required for the purposes of—
  - (a) the Factory and Workshop Act, 1901, or for any purpose connected with the employment in labour or

- elementary education of a young person under the age of sixteen years, or of a child;
- (b) the Unemployment Insurance Act, 1920;
- (c) the National Health Insurance Act, 1924;
- (d) the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1925;
- the Unemployment Assistance Act (Northern Ireland), 1934; or
- Savings Certificates Regulations made under sub-section (2) of section 1 of the Exchequer Borrowing and Local Loans Act (Northern Ireland), 1922;

shall be in the Form A. set forth in the Schedule to these Regulations.

- 2. The requisition to be made to entitle any person to obtain a certificate or certified copy of an entry of death required for the purposes of-
  - (a) the Unemployment Insurance Act, 1920;
  - (b) the Unemployment Assistance Act (Northern Ireland), 1934; or
  - Savings Certificates Regulations made under sub-section (2) of section 1 of the Exchequer Borrowing and Local Loans Act (Northern Ireland), 1922;

shall be in the Form B. set forth in the said Schedule.

- 3. The requisition to be made to entitle any person to obtain a certificate or certified copy of an entry of marriage required for the purposes of—
  - (a) the Unemployment Insurance Act, 1920;
  - (b) the National Health Insurance Act, 1924;
  - the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1925;
  - the Unemployment Assistance Act (Northern Ireland), 1934; or
  - Savings Certificates Regulations made under subsection (2) of section 1 of the Exchequer Borrowing and Local Loans Act (Northern Ireland), 1922;

shall be in the Form C. set forth in the said Schedule.

- 4. The Forms A., B. and C. in the said Schedule are approved for applications for Certificates of Births, Deaths and Marriages, respectively, required under the Savings Banks Act, 1887.
- 5. All Regulations and Orders now in force prescribing forms for the purposes mentioned in Regulations 1, 2 and 3 hereof are hereby revoked, so far as they apply in Northern Ireland and any approval hitherto given to forms of application, or to regulations as to applications, for certificates required under the

enactment mentioned in Article 4 hereof is hereby withdrawn, so far as such approval applies in Northern Ireland.

6. These Regulations may be cited as the Certificates of Births, Deaths and Marriages (Requisition) Regulations (Northern Ireland), 1934.
