

by order made after consultation with the Trustees suspend, for such time from the date of the Order as shall be specified in the Order, the payment of charges by owners of exported animals as required in the Act.

And whereas it is provided by Section One of the Exported Animals (Compensation) Act (Northern Ireland), 1932, that Section Thirteen of the principal Act shall have effect as if Ten Thousand Pounds were substituted therein for Five Thousand Pounds.

Now the Ministry of Agriculture by virtue and in exercise of the powers conferred on it by Section Thirteen of the principal Act doth hereby order as follows :—

1. The Ministry having been advised by the Trustees that the Compensation Fund amounts to Ten Thousand Pounds and consultation having taken place with said Trustees, the payment by owners of animals exported to Great Britain from Northern Ireland of the charges required by the principal Act is suspended as from the date hereof until 1st November, 1935.

2. This Order may be cited as the Slaughtered Animals (Compensation) Act (Northern Ireland), 1928, (Suspension of Charges) Order, 1934.

CENSUS OF PRODUCTION.

Date of Census.

ORDER OF THE MINISTRY OF COMMERCE, DATED 12TH DECEMBER, 1934, DETERMINING THAT A CENSUS OF PRODUCTION SHALL BE TAKEN IN THE YEAR 1936.

1934. No. 112.

WHEREAS by Section 1 sub-section (2) of the Census of Production Act, 1917, it is provided that a Census shall be taken in any year which is fixed for the purpose by an Order made by the Board of Trade and laid before Parliament :

Provided that there is at least a year's interval between the date on which the Order is made by the Board of Trade and the

commencement of the year in which the Census is to be taken.

And whereas, by virtue of the provisions of the Government of Ireland Act, 1920, and the several Orders in Council and Orders made thereunder, all the powers and functions of the Board of Trade under the said first-mentioned Act, so far as they relate to Northern Ireland, are now transferred to and vested in the Ministry of Commerce (in this Order referred to as "the Ministry").

Now, therefore, the Ministry, in pursuance of the powers conferred upon the Ministry by the said Section 1, sub-section (2) of the Census of Production Act, 1917, and of all other powers enabling the Ministry in that behalf, hereby makes the following Order :—

1. A Census of Production in Northern Ireland shall be taken in the year 1936 in respect of production in the year 1935.

2. This Order may be cited as "The Census of Production (1936) Order (Northern Ireland), 1934."

CIVIL AUTHORITIES (SPECIAL POWERS).

Explosive Substances.

REGULATION, DATED THE 11TH DAY OF JANUARY, 1934, MADE BY THE MINISTER OF HOME AFFAIRS UNDER THE CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND), 1922 AND 1933.

1934. No. 5.

WHEREAS certain Regulations for Peace and Order in Northern Ireland are contained in the Schedule to the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, and it is provided by sub-section (3) of section 1 of the said Act that the Minister of Home Affairs shall have power to make Regulations: (a) for making further provision for the preservation of the Peace and Maintenance of Order, and (b) for varying or revoking any provision of the Regulations, whether contained in the said Schedule, or made as aforesaid, and that any Regulations made as aforesaid shall, subject to the provisions of the said Act, have effect and be enforced in like manner as Regulations contained in the said Schedule :
