

THE PIGS MARKETING (NORTHERN IRELAND) (SPECIAL LEVY) (NO. 2) ORDER, 1934, DATED 22ND DECEMBER, 1934, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION 7 (3) OF THE AGRICULTURAL MARKETING ACT (NORTHERN IRELAND), 1933 (23 AND 24 GEO. 5, CH. 22).

Whereas by sub-section (3) of Section Seven of the Agricultural Marketing Act (Northern Ireland), 1933 (hereinafter referred to as "the Act") it is provided *inter alia* that the Ministry of Agriculture for Northern Ireland (hereinafter referred to as "the Ministry") may by order require the board administering a scheme regulating the marketing of an agricultural product to impose a special levy or levies for the purpose of covering any loss which the board have experienced in trading under the scheme :

And whereas the Pigs Marketing Board (Northern Ireland) (hereinafter referred to as "the Board") are the Board administering the Pigs Marketing Scheme (Northern Ireland), 1933, being a scheme for the time being in force under the Act, and have experienced a loss in trading under the said scheme estimated at £9,900, during the period 1st October, 1933, to 22nd December, 1934, inclusive :

And whereas a portion of this loss estimated at £5,000 has been met from the proceeds of the special levy of two shillings per pig imposed in pursuance of the provisions of the Pigs Marketing (Northern Ireland) (Special Levy) (No. 1) Order, 1934 :

And whereas the uncovered portion of the total loss is accordingly estimated at £4,900 :

Now, therefore, the Ministry, in exercise of the powers conferred upon it by the said sub-section and of every other power enabling it in that behalf, hereby makes the following Order, that is to say :—

1. The Board shall, during the period 24th December, 1934, to 2nd March, 1935, inclusive, for the purpose of meeting the said uncovered portion of the total loss, impose a special levy of six pence per pig upon all producers who are liable to pay a contribution under the provisions of Paragraph 40 of the Pigs Marketing Scheme (Northern Ireland), 1933, as approved by the Pigs Marketing Scheme (Northern Ireland) (Approval) Order, 1933, and as amended by the Pigs Marketing Scheme (Northern Ireland) (Amendment) Order, 1934, and by the Pigs Marketing Scheme (Northern Ireland) (Amendment) (No. 2) Order, 1934, or by any subsequent Order.

2. This Order may be cited as the Pigs Marketing (Northern Ireland) (Special Levy) (No. 2) Order, 1934, and shall come into force on the 24th December, 1934.

Packing of Dead Poultry.

THE AGRICULTURAL PRODUCE (MEAT REGULATION) RULES (NORTHERN IRELAND), 1934, DATED THE 20TH DAY OF JUNE, 1934.

1934. No. 49.

The Ministry of Agriculture by virtue and in exercise of the powers for this purpose vested in it by the Agricultural Produce (Meat Regulation) Act (Northern Ireland), 1930, and of every other power in that behalf enabling it, hereby makes the Rules following, that is to say:—

Short Title.

1. These Rules shall be known as the "Agricultural Produce (Meat Regulation) Rules (Northern Ireland), 1934."

Packing of Dead Poultry.

2. All packages, including wrappers, cases, containers, casks, crates or other receptacles containing dead poultry to be sent out of Northern Ireland to Great Britain, The Irish Free State or the Isle of Man, shall be (1) thoroughly clean, and packages which have contained any substance likely to contaminate the contents shall not be used; and (2) so packed as to ensure that the packages shall contain no diseased, emaciated or unsound poultry carcasses.

Commencement.

3. This Order shall come into operation as from the date hereof.
