- 6. In addition to remuneration at the above-mentioned rates, the members of the Tribunal shall be entitled to travelling expenses and subsistence at the rates set out above for Assessors.
- 7. Applicants for the grant of rights or for the imposition of restrictions on the working of minerals required for support shall pay to the Ministry of Commerce a fee of £1 in respect of each application.

County Court Rules.

THE MONEYLENDERS ACT (NORTHERN IRELAND), 1933, COUNTY COURT RULES, 1934, DATED THE 13TH DAY OF DECEMBER, 1934.

1934. No. 130.

Whereas by an Act, 40 and 41 Vict., C. 56, intituled "The County Officers and Courts (Ireland) Act, 1877," Section 79, it is enacted that the Lord Chancellor, with the concurrence of the County Court Judges and Chairmen of Quarter Sessions in Ireland, or any five of them, to be selected or nominated as in the said Act is provided, may make rules and orders for regulating the proceedings in and practice of the Civil Bill Courts in Ireland and for prescribing the forms of proceedings, and for the several other purposes in the said Act mentioned, and otherwise for carrying the said Act into execution, and may from time to time amend such rules, orders and forms, and that every such rule, order and form certified under the hands of the Lord Chancellor and any five of such Judges and Chairmen shall take effect from and after such day as shall be therein named:

And whereas under and in pursuance of the provisions of the Government of Ireland Act, 1920, and the Orders made by His Majesty in Council thereunder, the references in the said section

to the Lord Chancellor shall be construed as references to the Lord Chief Justice of Northern Ireland:

And whereas by the County Officers and Courts Act (Northern Ireland), 1925, Section 10, the concurrence required in connection with the making by the Lord Chief Justice of Northern Ireland of rules or orders under Section seventy-nine of the County Officers and Courts (Ireland) Act, 1877, shall be the concurrence of the Chairmen within the meaning of the said Act, or any two of them to be nominated by the said Lord Chief Justice:

And whereas the Lord Chief Justice of Northern Ireland duly nominated His Honour Herbert Marshall Thompson, Recorder of Belfast and County Court Judge and Chairman of Antrim, and His Honour Arthur Henry Bates, County Court Judge and Chairman of the County of Down, as the Chairmen with whose concurrence such rules and orders may be made in pursuance

of the provisions of the said Act:

And whereas by an Act 23 & 24 Geo. V., Chap. 23, intituled The Moneylenders (Northern Ireland) Act, 1933, Section 18, it is provided that "Notwithstanding the provisions of section five of the Civil Bill Courts Procedure Amendment Act (Ireland), 1871, no special warrant shall be given for the execution of any decree obtained by or at the suit of a moneylender in respect of a moneylending transaction.

The authority having power to make rules and orders for regulating the practice of the civil bill courts may make rules for the purpose of carrying into effect the objects of this section."

Now I, The Right Honourable Sir William Moore, Baronet, Lord Chief Justice of Northern Ireland, with the concurrence of the said Judges as testified by their signatures hereto, in pursuance of the powers given by the said recited Acts, and of all other powers thereunto us enabling, do hereby make and certify the rules hereinafter set forth as rules to be in force in proceedings in the County Courts under the Moneylenders Act (Northern Ireland), 1933.

- 1. The following Rule shall be added to Order III of The County Courts (Ireland) Orders, 1890, and shall stand as Rule 10:
 - "10. All civil bills in actions by a moneylender or the assignee or personal representative of a deceased moneylender for the recovery of money lent by a moneylender or any interest thereon or the enforcement of any agreement or security relating to any such money or interest which are subject to the provisions of the Moneylenders Act (Northern Ireland), 1933, shall state the fact that it is brought at the suit of a licensed moneylender (or of his assignee or personal representative as the case may be) and is in respect of a moneylending transaction within the provisions of the Moneylenders Act (Northern Ireland), 1933, and shall be headed with the words 'Moneylenders Act (Northern Ireland), 1933.'"

2. The following Rule shall be added to Order XVI of The County Courts (Ireland) Orders, 1890, and shall stand as Rule 12:

- "12. At the hearing of every Civil Bill brought for the recovery of any money lent by a moneylender, or any interest thereon, or the enforcement of any agreement or security relating to such money or interest, the Judge, whether the defendant, or any of the defendants, appears or not, may exercise the powers of the Court under Section 1, sub-section one, of The Moneylenders Act, 1900, as extended by Section ten of The Moneylenders Act (Northern Ireland), 1933."
- 3. The following Rule shall be added to Order XVII of The County Courts (Ireland) Orders, 1890. and shall stand as Rule 9:
 - "9. Every decree taken out by or at the suit of a moneylender (or of his assignee or personal representative as the case may be) in respect of a moneylending transaction shall be headed with the words:—'This decree is within The Moneylenders Act (Northern Ireland), 1933.'"
