1. Paragraph (e) of Article 1 of the Pigs Marketing Scheme (Northern Ireland) (Amendment) Order, 1934, which modified paragraph 40 of the Pigs Marketing Scheme (Northern Ireland), 1933, is hereby revoked, and the said paragraph 40 shall have effect as if the said modification had not been made:

Provided that such revocation shall not affect:-

- (1) the previous operation of the said paragraph 40 as so modified or anything duly done or suffered thereunder; or
- (2) any right, privilege, obligation or liability acquired, accrued or incurred thereunder; or
- (3) any penalty incurred in respect of any offence committed against the said paragraph 40 as so modified; or
- (4) any investigation, legal proceeding or remedy in respect of any such right, privilege, obligation, liability or penalty as aforesaid; and any such investigation, legal proceeding or remedy may be instituted, continued or enforced, and any such penalty may be imposed as if this Order had not been made.
- 2. This Order may be cited as "The Pigs Marketing Scheme (Northern Ireland) (Amendment) (No. 2) Order, 1934," and shall come into force on the 1st November, 1934.

THE MARKETING OF PIGS (REGISTRATION OF DEALERS) REGULATIONS (NORTHERN IRELAND), 1934, DATED 1ST FEBRUARY, 1934, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER PARAGRAPH (b) OF SUB-SECTION (1) OF SECTION FOURTEEN OF THE AGRICULTURAL MARKETING ACT (NORTHERN IRELAND), 1933 (23 & 24 GEO. 5, CH. 22).

Whereas by Sub-section (1) of Section Fourteen of the Agricultural Marketing Act (Northern Ireland), 1933 (hereinafter referred to as "the Act") it is provided *inter alia* that the Ministry of Agriculture for Northern Ireland (hereinafter referred to as "the Ministry") may by regulations make such provision

as appears to the said Ministry to be necessary for regulating the removal from Northern Ireland to Great Britain of any agricultural product the marketing of which is regulated by a scheme for the time being in force under the Act or under the Agricultural Marketing Act, 1931, the quantity of the product or of any description thereof which may be so removed, and the descriptions of the product which may be so removed, and in particular (without prejudice to the generality of the foregoing provision) for the following matters:—

- (i) the registration of persons carrying on business in Northern Ireland as dealers in the regulated product;
- (ii) the exemption from registration of such classes of persons carrying on business as aforesaid as the regulations may specify;

And whereas pigs are an agricultural commodity the marketing of which is regulated by the Pigs Marketing Scheme (Northern Ireland), 1933, being a scheme for the time being in force under the Act:

Now therefore the Ministry, in exercise of the powers conferred upon it by the said Sub-section and of every other power enabling it in that behalf, hereby makes the following regulations, that is to say:—

Short Title and Commencement.

1. These Regulations may be cited as the Marketing of Pigs (Registration of Dealers) Regulations (Northern Ireland), 1934 and shall come into force on 12th day of February, 1934.

Interpretation.

- 2.—(1) In these Regulations, except where the context otherwise requires:—
 - "Pigs" means pigs produced in Northern Ireland:
 - "Pig dealer" means a person carrying on business in Northern Ireland as a dealer in pigs:
 - "Registered" means registered under these Regulations, and registration shall be construed accordingly.
- (2) The Interpretation Act, 1921, shall apply for the interpretation of these Regulations as it applies for an Act of the Parliament of Northern Ireland.

Registration of Dealers.

- 3. The Ministry shall keep a register of pig dealers, and every pig dealer shall, on application to the Ministry, be entitled to be registered therein.
- 4. Any pig dealer who does not remove pigs from Northern Ireland to Great Britain shall be exempt from registration.

5. The Ministry, on being satisfied that a person who is registered has died or has ceased to be a pig dealer or is exempt from registration, shall remove his name from the register:

Provided that the name of a person shall not be removed from the register without his consent by reason that he has ceased to be a pig dealer or is exempt from registration.

- 6. No person, other than a registered pig dealer, shall remove or attempt to remove any pigs from Northern Ireland to Great Britain, except with the approval of the Ministry.
