DRAINAGE

modify the decision of the county council or other drainage authority as the case may be or remit the matter to the county council or other drainage authority with the opinion of the county court thereon or make such other order in the matter as the court thinks just;

(b) in the case of an appeal by a person served with a notice in pursuance of the provisions of paragraph (b) of sub-section (4) of section 5 of the Drainage Act (Northern Ireland), 1933, either confirm or annul the notice to which the appeal relates or vary any requirement thereof;

(c) in the case of (a) and (b) make such order as to costs to be paid by either party as the court thinks just.

(7) The decision of the county court shall be binding on all parties; Provided that the county court may, if it thinks fit, state the facts specially for the determination of a superior court.

2. The Drainage (Appeals to County Court) Regulations, 1930, are hereby revoked.

3. These Regulations may be cited as "The Drainage (Appeals to County Court) Regulations, 1934."

The Ministry of Home Affairs for Northern Ireland in exercise of the powers vested in it by sub-section (7) of section 5 of the . Drainage Act (Northern Ireland), 1933, and of all other powers in that behalf enabling it, hereby makes the following regulations :

1. Every notice served by a county council under sub-section (2) of section 5 of the Drainage Act (Northern Ireland), 1933, shall be in Form No. 1 set out in the Schedule hereto.

2. Every notice served by a county council under paragraph (b) of sub-section (4) of section 5 of the Drainage Act (Northern Ireland), 1933, shall be in form No. 2 set out in the Schedule hereto.

3. The Drainage (Notice to Cleanse Watercourses) Order (Northern Ireland), 1930, is hereby revoked.

4. This Order may be cited as "The Drainage (Notices to Cleanse Watercourses) Order, 1934."
