premium to be paid to the said Company and from and after the expiration of such current year of Guarantee in the last mentioned case cease and determine and neither the said Company nor the funds or property of the said Company shall be liable to make good or indemnify or save harmless the said Local Authority from or against any loss or damage costs and expenses which the said Local Authority shall or may sustain or incur by or through any default of the said person employed. Provided always that notwithstanding the determination of this Policy of Guarantee in either of the cases aforesaid it shall be deemed and taken to be an existing Policy of Guarantee in respect of all liabilities which the said Company shall or may have incurred thereon prior to such determination as aforesaid.

Public Bodies: Stamp Duties on Rate Receipts.

THE PUBLIC BODIES ORDER, 1934, DATED THE 18TH DAY OF MAY, 1934.

1934. No. 42.

The Ministry of Home Affairs for Northern Ireland, in pursuance of the powers vested in it by the Local Government Acts (Northern Ireland) 1898 to 1929 and of all other powers in this behalf enabling the Ministry, hereby orders and directs as follows, that is to say:—

1. This Order may be cited as "The Public Bodies Order, 1934."

2. The following paragraph shall be added to and be read with Article 96 of the Public Bodies Order, 1904 (in this Order referred

to as "the principal Order"):-

"Where the Council has been duly authorised, in lieu of affixing 2d. stamps to Rate Receipts for £2 or upwards, to pay the stamp duty half-yearly by means of a Paying Order he shall enter in the appropriate column on the prescribed form (Form 60a.) the number of items on Form 60 in respect of which a sum of £2 or over has been received and shall not later than the first day of January and the first day of July in each year complete and forward the prescribed form (Form 60b.) in respect of the half-years ended 30th September and 31st March, respectively, to the Secretary, Ministry of Finance, Stormont, Belfast, with a Paying Order for the amount which would have been expended had 2d. stamps been affixed to the receipts set out in Form 60a."

- 3. The Schedule to this Order shall be added to the Schedule to the principal Order and the principal Order and this Order shall be read and construed as one.
 - 4. This Order shall be deemed to have come into force on the 1st day of April, 1934.

ORDER, DATED THE 18TH DAY OF JULY, 1934, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION 33 (2) OF THE LOCAL GOVERNMENT (IRELAND) ACT, 1898.

1934. No. 54.

To the Council of each Rural District in Northern Ireland: And to all others whom it may concern:

Whereas it is enacted in effect by section 33 (2) of the Local Government (Ireland) Act, 1898 that rural district councils shall have such powers and duties of urban sanitary authorities under the Public Health Acts or any other Act and such provisions of any of those Acts relating to urban districts shall apply to rural districts as the Ministry of Home Affairs for Northern Ireland may by general order direct and that every such order shall be forthwith laid before Parliament:
