

(4) That a dealer in explosives shall be required to keep all invoices, consignment notes, receipts, and permits, for a period of one year, from the date of the transaction to which they relate.

(5) That no person shall make in any Register or document which he is required to keep under the Order, any entry which is false or misleading in any material particular.

Collection of Contributions.

THE CONTRIBUTORY PENSIONS AND UNEMPLOYMENT INSURANCE (COLLECTION OF CONTRIBUTIONS FOR PERSONS OVER 65) REGULATIONS (NORTHERN IRELAND), 1934, DATED 10TH SEPTEMBER, 1934, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE AND THE MINISTRY OF LABOUR FOR NORTHERN IRELAND.

The National Health Insurance Joint Committee and the Ministry of Labour for Northern Ireland acting jointly in exercise of the powers conferred on them by sub-section (1) of section 10 of the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1925, and of all other powers enabling them in that behalf, hereby make the following Regulations:—

1. These Regulations may be cited as the Contributory Pensions and Unemployment Insurance (Collection of Contributions for Persons over 65) Amendment Regulations (Northern Ireland), 1934, and shall be read as one with the Contributory Pensions and Unemployment Insurance (Collection of Contributions for Persons over 65) Regulations (Northern Ireland) 1928 (hereinafter referred to as "the regulations of 1928").

2. Article 8 of the regulations of 1928 is hereby revoked, but without prejudice to any right, privilege, obligation or liability acquired, accrued or incurred thereunder, and the following article is substituted therefor :—

“ A person over 65 shall not be entitled to pay any contribution in respect of any period of unemployment or incapacity for work occurring after the date on which he attained the age of 65 and accordingly shall not affix any stamps to his card in respect of any such period.”
