**Pigs, Marketing of : Compensation.**

THE AGRICULTURAL MARKETING (NORTHERN IRELAND) (COMPENSATION) ORDER, 1934, DATED 14TH NOVEMBER, 1934, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SUB-SECTION (3) OF SECTION SEVEN OF THE AGRICULTURAL MARKETING ACT (NORTHERN IRELAND), 1933, (23 AND 24 GEO. 5, CH. 22) AND UNDER SECTION FIVE OF THE AGRICULTURAL MARKETING ACT (NORTHERN IRELAND), 1934, (24 AND 25 GEO. 5, CH. 6).

The Ministry of Agriculture for Northern Ireland (hereinafter referred to as "the Ministry.") by virtue and in exercise of the powers conferred upon it by Sub-section (3) of Section Seven of the Agricultural Marketing Act (Northern Ireland), 1933, and by Section Five of the Agricultural Marketing Act (Northern Ireland), 1934, and of every other power enabling it in that behalf hereby makes the following Order :—

1. In the event of the Bacon Marketing Board (Northern Ireland) raising a loan before the fifth day of June, 1935, for the purpose of paying compensation to registered producers of bacon in respect of losses occasioned to such producers during the period 16th September, 1933, to 31st December, 1933, inclusive, by the operation of the Pigs Marketing Scheme (Northern Ireland), 1933, and in the event of the said Board being granted sums by the Pigs Marketing Board (Northern Ireland) for the purpose of paying the principal and interest on the said loan then the said loan and the said sums shall be applied for the said respective purposes and in accordance with the terms of any agreements made between the said Boards and between the said Bacon Marketing Board and the Ministry of Finance for Northern Ireland.

2. Any compensation which may be paid by the Bacon Marketing Board (Northern Ireland) to registered producers of bacon in

respect of losses experienced by such producers during the period 16th September, 1933, to 31st December, 1933, inclusive, shall be at the rate of five shillings in respect of each pig purchased by such producers in accordance with the prices determined by the Pigs Marketing Board (Northern Ireland) during the aforementioned period.

3. The Pigs Marketing Board (Northern Ireland) are hereby empowered to grant to the Bacon Marketing Board (Northern Ireland) such sums as the last-mentioned Board may be liable to pay on account of principal or interest in respect of the loan referred to in Article One of this Order and to guarantee the payment by the said Bacon Marketing Board of the aforesaid sums.

4. The Pigs Marketing Board (Northern Ireland) shall, for the purpose of providing for the granting of the sums mentioned in Article Three of this Order, impose a special levy of one shilling per pig upon all producers of pigs who are liable to pay a contribution under the provisions of Paragraph 40 of the Pigs Marketing Scheme (Northern Ireland), 1933, as approved by the Pigs Marketing Scheme (Northern Ireland) (Approval) Order, 1933, and as amended by the Pigs Marketing Scheme (Northern Ireland) (Amendment) Order, 1934, and by the Pigs Marketing Scheme (Northern Ireland) (Amendment) (No. 2) Order, 1934, or by any subsequent Order.

5. The Pigs Marketing Scheme (Northern Ireland), 1933, as approved by the Pigs Marketing Scheme (Northern Ireland) (Approval) Order, 1933, and as amended by the Pigs Marketing Scheme (Northern Ireland) (Amendment) Order, 1934, and by the Pigs Marketing Scheme (Northern Ireland) (Amendment) (No. 2) Order, 1934, shall have effect with the amendments set out in the First Schedule hereto.

6. The Bacon Marketing Scheme (Northern Ireland), 1933, as approved by the Bacon Marketing Scheme (Northern Ireland) (Approval) Order, 1933, shall have effect with the amendments set out in the Second Schedule hereto.

7. This Order may be cited as the Agricultural Marketing (Northern Ireland) (Compensation) Order, 1934.

## FIRST SCHEDULE.

## AMENDMENTS OF THE PIGS MARKETING SCHEME (NORTHERN IRELAND), 1933.

1. In Paragraph 26 after the words " operation of this Scheme " there shall be inserted the words " or for any grant which the Board are empowered to make or for any payment which they may be liable to make under any guarantee which they are empowered to give."

2. After Paragraph 40 there shall be inserted the following new paragraph :—

" 40A. A special levy of one shilling per pig shall be paid by a producer upon the sale of any pigs by him to a curer or to the Board.

Such special levy shall remain in force until sufficient monies are available to pay off the principal and interest on the loan raised by the Bacon Marketing Board (Northern Ireland) for the purpose of paying compensation to registered curers in respect of losses occasioned to such curers during the period 16th September, 1933, to 31st December, 1933, inclusive, by the operation of this Scheme. Such special levy shall be deducted from the price paid by a curer for pigs purchased by him and shall be paid by the curer to the Board in such manner and at such times as the Board may determine :

Provided that this provision shall be without prejudice to any other method of recovering such special levy which is authorised by the Act."

3. In Paragraph 41 after the words " operation of this Scheme " there shall be inserted the words " or for any grant which the Board are empowered to make or for any payment which they may be liable to make under any guarantee which they are empowered to give."

## SECOND SCHEDULE.

## AMENDMENTS OF THE BACON MARKETING SCHEME (NORTHERN IRELAND), 1933.

1. In Paragraph 28 after the words " under this Scheme " there shall be inserted the words " or for the purpose of paying compensation to registered producers in respect of any loss, which, in the opinion of the Board, has been occasioned to them by the operation of this or any other Scheme administered under the Act."

2. After Paragraph 28 there shall be inserted the following new paragraphs :—

" 28A. The Board may, where a loan is proposed to be made to them for the purpose of paying compensation to registered producers in respect of losses which have been occasioned to such producers during the period 16th September, 1933, to 31st December, 1933, inclusive, by the operation of the Pigs Marketing Scheme (Northern Ireland), 1933, agree with any person proposing to guarantee the repayment of the loan that, if a guarantee is duly given, the Board will apply the money obtained by them by means of the loan for the said purpose subject to such conditions as may be specified in the agreement. The Board may further, where the Pigs Marketing Board (Northern Ireland) propose to grant to them sums of money for the purpose of paying the principal or interest of such a loan, agree with the said Pigs Marketing Board that the said sums will be applied for the said purpose subject to such conditions as may be specified in the agreement."

" 28B. The Board shall carry into effect any agreement entered into by them pursuant to the preceding paragraph."

" 28C. Subject to any obligation of the Board under any agreement made in pursuance of paragraph 28A, the Board may pay out of any loan made to them compensation to registered producers in respect of the losses referred to in paragraph 28A of this Scheme."
