### Periods of Occasional Sickness.

RULES MADE BY THE UNEMPLOYMENT ASSISTANCE BOARD FOR NORTHERN IRELAND UNDER SECTIONS 31 (2) AND 46 (1) OF THE UNEMPLOYMENT ASSISTANCE ACT (NORTHERN IRELAND), 1934 (24 & 25 GEO. V. CH. 12).

1935. No. 10.

1. The Unemployment Assistance Board for Northern Ireland in exercise of the powers conferred on it by Section 46 of the Unemployment Assistance Act (Northern Ireland), 1934, and of all other powers in that behalf hereby makes the following Rules.

2. A person who, during the currency of a determination granting him an allowance, falls sick or is otherwise incapacitated shall, provided such sickness or incapacity is occasional, be deemed for the purpose of Section 31 of the Unemployment Assistance Act (Northern Ireland), 1934, to be capable of and available for work notwithstanding such sickness or incapacity during the following periods, that is to say:—

- (a) during the whole of any period of sickness or incapacity which does not extend to two complete pay weeks ; and
- (b) during the period ending with the termination of the first complete pay week of any sickness or incapacity the duration of which extends to or exceeds two complete pay weeks.

3. The expression " pay week " means the period in respect of which payment of allowances is made.

4.—(1) These Rules may be cited as the Unemployment Assistance (Periods of Occasional Sickness) Rules (Northern Ireland), 1935.

(2) The Interpretation Act, 1921, applies to the interpretation of these Rules as it applies to the interpretation of an Act of Parliament.

5. These Rules shall be deemed to have had effect as from and after the 7th day of January, 1935.

### Residence Qualification.

RULES MADE BY THE UNEMPLOYMENT ASSISTANCE BOARD FOR NORTHERN IRELAND UNDER SECTIONS 31 (1) AND 46 (1) OF THE UNEMPLOYMENT ASSISTANCE ACT (NORTHERN IRELAND), 1934.

1935. No. 11.

The Unemployment Assistance Board for Northern Ireland in pursuance of the powers conferred upon it by sub-section (1) of Section 31 and sub-section (1) of Section 46 of the Unemployment Assistance Act (Northern Ireland), 1934, and of all other powers enabling it in that behalf makes the following Rules :—

1. In determining whether an applicant has fulfilled the residence qualification no account shall be taken of residence outside the United Kingdom for any cause for a period not exceeding five years or for such longer period as may be due to :—

- (a) Employment in the Navy, Army, or Air Force ;
- (b) Employment within the meaning of the Unemployment Insurance Acts as in force in Great Britain or Northern Ireland as a master seaman or apprentice to the sea service and sea fishing service ;
- (c) Any other cause which in the opinion of the Unemployment Assistance Board for Northern Ireland was in all the circumstances reasonable.

2.—(1) These Rules may be cited as the Unemployment Assistance (Residence Qualification) Rules (Northern Ireland), 1935, and shall have effect as from the seventh day of January, nineteen hundred and thirty-five.
