### Residence Qualification.

RULES MADE BY THE UNEMPLOYMENT ASSISTANCE BOARD FOR NORTHERN IRELAND UNDER SECTIONS 31 (1) AND 46 (1) OF THE UNEMPLOYMENT ASSISTANCE ACT (NORTHERN IRELAND), 1934.

1935. No. 11.

The Unemployment Assistance Board for Northern Ireland in pursuance of the powers conferred upon it by sub-section (1) of Section 31 and sub-section (1) of Section 46 of the Unemployment Assistance Act (Northern Ireland), 1934, and of all other powers enabling it in that behalf makes the following Rules :—

1. In determining whether an applicant has fulfilled the residence qualification no account shall be taken of residence outside the United Kingdom for any cause for a period not exceeding five years or for such longer period as may be due to :—

- (a) Employment in the Navy, Army, or Air Force ;
- (b) Employment within the meaning of the Unemployment Insurance Acts as in force in Great Britain or Northern Ireland as a master seaman or apprentice to the sea service and sea fishing service ;
- (c) Any other cause which in the opinion of the Unemployment Assistance Board for Northern Ireland was in all the circumstances reasonable.

2.—(1) These Rules may be cited as the Unemployment Assistance (Residence Qualification) Rules (Northern Ireland), 1935, and shall have effect as from the seventh day of January, nineteen hundred and thirty-five.

(2) The Interpretation Act, 1921, applies to the interpretation of these Rules as it applies to the interpretation of an Act of Parliament.

### Transitory Provisions.

RULES MADE BY THE UNEMPLOYMENT ASSISTANCE BOARD FOR NORTHERN IRELAND UNDER SECTION 46 OF THE UNEMPLOYMENT ASSISTANCE ACT (NORTHERN IRELAND,) 1934.

1935. No. 15.

1. The Unemployment Assistance Board for Northern Ireland, in exercise of the powers conferred on it by Section 46 of the Unemployment Assistance Act (Northern Ireland), 1934, and of all other powers in that behalf hereby makes the following rules.

2. An application for an allowance made by a person to whom these Rules apply may be taken into consideration before the second appointed day without requiring that person to prove that he fulfils the conditions prescribed by Article 1 (2) (a) of the Unemployment Insurance (Economy) (No. 2) Order, Northern Ireland, 1931.

3. The persons to whom these Rules apply are persons who fulfil the conditions prescribed by Article 1 (2) (b) of the Order aforesaid in whose case either of the following conditions is fulfilled, namely:—

- (1) that unemployment benefit has become payable in respect of a day on or after the first appointed day; or
- (2) (a) that the question whether he was in need of assistance by way of transitional payments has been
