ORDER OF THE MINISTER OF HOME AFFAIRS, DATED 24TH JULY, 1935, APPOINTING THE DAY FOR THE COMING INTO FORCE OF CERTAIN PROVISIONS OF THE SUMMARY JURISDICTION AND CRIMINAL JUSTICE ACT (NORTHERN IRELAND), 1935.

WHEREAS it is provided by section 63 of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935 (hereinafter referred to as "the Act"), that the Act shall come into operation on the Appointed Day, and the Appointed Day for the purposes of the Act shall be such day as the Minister of Home Affairs may appoint, and different days may be appointed for different purposes and different provisions of the Act :

Now, therefore, I, the Minister of Home Affairs, hereby order as follows :—

The Twenty-fifth day of July, 1935, is hereby fixed to be the Appointed Day for the coming into force of the following provisions of the Act :—Section 55 and so much of Section 62 and the Fifth Schedule to the Act as repeals sub-section 5 of Section 11 of the Criminal Law and Procedure (Ireland) Act, 1887.

ORDER OF THE MINISTER OF HOME AFFAIRS, DATED 4TH NOVEMBER, 1935, APPOINTING THE DAY FOR THE COMING INTO OPERATION OF CERTAIN PROVISIONS OF THE SUMMARY JURISDICTION AND CRIMINAL JUSTICE ACT (NORTHERN IRELAND), 1935.

WHEREAS it is provided by Section 63 of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935 (hereinafter referred to as "the Act"), that the Act shall come into operation on the Appointed Day, and the Appointed Day for the purposes of the Act shall be such Day as the Minister of

Home Affairs may appoint, and different days may be appointed for different purposes and different provisions of the Act :

And whereas, by Order dated the 24th day of July, 1935, the twenty-fifth day of July, 1935, was fixed to be the Appointed Day for the coming into force of Section 55 and so much of Section 62 and the Fifth Schedule to the Act as repeals sub-section 5 of Section 11 of the Criminal Law and Procedure (Ireland) Act, 1887 :

Now, therefore, I, The Right Honourable Sir Richard Dawson Bates, D.L., M.P., Minister of Home Affairs for Northern Ireland, do hereby order as follows :—

The first day of January, 1936, shall be the Appointed Day for the coming into operation of all such provisions of the Act as have not already been brought into operation by the said Order, dated 24th day of July, 1935.

### Form of Affidavit of Service.

ORDER OF THE MINISTRY OF HOME AFFAIRS, DATED 9TH NOVEMBER, 1935, MADE IN EXERCISE OF POWERS CONTAINED IN THE SUMMARY JURISDICTION AND CRIMINAL JUSTICE ACT (NORTHERN IRELAND), 1935.

The Ministry of Home Affairs in exercise of the powers vested in it by the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935, and of every other power in this behalf enabling the Ministry hereby makes and prescribes the following Regulations :—

An affidavit of service of summons pursuant to section 33 of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935, shall be in the form in the Schedule hereto with such variations as circumstances may require ; such affidavit shall be sworn before a Justice of the Peace.
