corresponding fees (including mileage allowances) directed to be paid to the Medical Referee under Regulations 19, 14, 35 and 24 respectively of the Workmen's Compensation (Medical Referees) Regulations, (Northern Ireland), 1935, dated March 13th, 1935.(a)

Provided that where a Medical Referee is summoned to sit as assessor in more than one case on the same day, then in each case for which the Referee was summoned on the application of a party the amount payable by the applicants in respect of mileage allowance shall be a sum equivalent to the total mileage allowance (if any) payable to the Referee under No. 35 of the said Regulations, divided by the total number of cases for which the Referee was summoned to sit on that day.

2. This Order may be cited as the Workmen's Compensation (Medical Referees) Order (Northern Ireland), 1935, and shall come into force on the 1st day of July, 1935.

## Transfer of Funds.

THE WORKMEN'S COMPENSATION (TRANSFER OF FUNDS) RULES (NORTHERN IRELAND), 1935, DATED THE 28TH DAY OF MAY, 1935.

## 1935. No. 67.

Whereas by an Act, 40 and 41 Vict., C. 56, intituled "The County Officers and Courts (Ireland) Act, 1877," Section 79, it is enacted that the Lord Chancellor, with the concurrence of the County Court Judges and Chairmen of Quarter Sessions in Ireland, or any five of them, to be selected or nominated as in the said Act is provided, may make rules and orders for regulating the proceedings in and practice of the Civil Bill Courts in Ireland, and for prescribing the forms of proceedings and for the several other purposes in the said Act mentioned, and otherwise for carrying the said Act into execution, and may from time to time amend such rules, orders and forms, and that every such rule, order and form certified under the hands of the Lord Chancellor, and any five of such Judges and Chairmen, shall take effect from and after such day as shall be therein named:

And whereas under and in pursuance of the provisions of the Government of Ireland Act, 1920, and the Orders made by His Majesty in Council thereunder, the references in the said section to the Lord Chancellor shall be construed as references to the Lord Chief Justice of Northern Ireland:

And whereas by the County Officers and Courts Act (Northern Ireland), 1925, Section 10, the concurrence required in connection with the making by the Lord Chief Justice of Northern Ireland of rules or orders under Section seventy-nine of the County Officers and Courts (Ireland) Act, 1877, shall be the concurrence of the Chairmen within the meaning of the said Act or any two of them to be nominated by the said Lord Chief Justice:

And whereas the Lord Chief Justice of Northern Ireland duly nominated His Honour Herbert Marshall Thompson, Recorder of Belfast and County Court Judge and Chairman of Antrim, and His Honour Arthur Henry Bates, County Court Judge and Chairman of the County of Down, as the Chairmen with whose concurrence such rules and orders may be made in pursuance of the provisions of the said Act:

And whereas by an Act 17 and 18 Geo. 5, C. 16, S. 27, intituled "The Workmen's Compensation Act (Northern Ireland), 1927," it is provided that the duty of a county court judge under the said Act shall, subject to Rules of Court, be part of the duties of the county court, and that the officers of the Court shall act accordingly; and that Rules of Court may be made both for any purpose for which the said Act authorizes Rules of Court to be made, and also generally for carrying the said Act into effect, so far as it affects the county court and proceedings in the county court; and that such rules may be made by the authority having power to make rules under Section seventy-nine of the County Officers and Courts (Ireland) Act, 1877, as amended by Section 10 of the County Officers and Courts Act (Northern Ireland), 1925:

And whereas by virtue of the Workmen's Compensation Act (Northern Ireland), 1927, Section 38, for the purpose of giving effect to a resolution adopted at an Imperial Conference held in London in the year nineteen hundred and twenty-six, it was provided that Rules of Court might be made under that Act to provide for the transfer, receipt and administration, at the request of the authority by which the award is made, of sums awarded under the law relating to workmen's compensation from one part of the Empire to beneficiaries resident or becoming resident in another part of the Empire.

Now I, The Right Honourable Sir William Moore, Baronet, Lord Chief Justice of Northern Ireland, with the concurrence of the said Judges, as testified by their signatures hereto, in pursuance of the powers given by the said recited Acts, and of all other powers thereunto Us enabling, do hereby make and certify the rules hereinafter set forth as rules to be in force in proceedings in the County Courts under the Workmen's Compensation Acts, 1906—1927.

1. The following rule shall be inserted in the Workmen's Compensation Rules, 1929, after Rule 89A, and shall stand as Rule 89B.:

Section 38. Transfer of funds to, and receipt and administration of funds transmitted from His Majesty's Dominions.

89B.—(1) Where money (other than a weekly payment under Rule 66 or arrears of weekly payments under Rule 67) is paid into a County Court in Northern Ireland as compensation under the Act for the benefit of any workman or dependants resident or about to reside in another part of His Majesty's dominions mentioned in the first column of the Schedule to this Rule, the Judge of the Court in Northern Ireland may, on the application of the workman or dependants, order the money to be transferred to the other part of His Majesty's dominions, to be paid to or administered for the benefit of the workman or dependants in such manner as the appropriate authority in the other part of His Majesty's dominions may think fit, and may in the order make any request regarding the administration of the money.

- (2) Where an order has been made for the transfer of money under the last preceding paragraph, the Clerk of the Crown and Peace shall send in an envelope addressed as prescribed in the second column of the Schedule a sealed copy of the order and at the same time forward under cover to the officer prescribed in the third column of the Schedule a crossed cheque payable to that officer. Where the payee is not the officer to whom the copy of the order is sent, the Clerk of the Crown and Peace shall, in forwarding the copy of the order, inform the addressee that a cheque is being so transmitted.
- (3) Where money paid under the law relating to workmen's compensation in force in a part of His Majesty's dominions mentioned in the first column of the Schedule is transferred in pursuance of an order of the competent authority in that part of His Majesty's dominions to a County Court in Northern Ireland for the benefit of a workman or dependants residing within the jurisdiction of that Court, the money shall be received by the appropriate County Court and administered by that Court for the benefit of the workman or dependants, due regard being had to such direction (if any) as may be contained in the order of the transmitting Court regarding the administration of the money.
- (4) On receipt of the money the Clerk of the Crown and Peace shall send notice in writing thereof to the workman or dependants and may require him or them to attend upon him or at the Court in order that he or they may give the Clerk of the Crown and Peace such information as the Court may require for the purpose of administering the said money.
