

### King's Scholarship Examinations.

REGULATIONS, DATED 6TH APRIL, 1936, MADE BY THE MINISTRY OF EDUCATION, NORTHERN IRELAND, UNDER SECTION 65 OF THE EDUCATION ACT (NORTHERN IRELAND), 1923, AND LAID BEFORE PARLIAMENT IN TERMS OF SECTION 99 (3) OF THE ACT AFORESAID.

NOTE :—The foregoing Regulations being, temporary in effect, have not been printed at length in this volume.

### Preparatory, Intermediate and Secondary Schools : Teachers.

REGULATIONS, DATED THE TWELFTH DAY OF OCTOBER, 1936, MADE BY THE MINISTRY OF EDUCATION FOR NORTHERN IRELAND UNDER SECTIONS 65, 69 AND 77 OF THE EDUCATION ACT (NORTHERN IRELAND), 1923 (13 AND 14 GEO. 5, CH. 21), AFTER CONSULTATION WITH THE MINISTRY OF FINANCE AND LAID BEFORE PARLIAMENT IN ACCORDANCE WITH THE PROVISIONS OF SECTION 99 (2) OF THE ACT AFORESAID.

1. These Regulations may be cited as the "Regulations for Secondary Teachers (Northern Ireland), 1935, Amending Regulations No. 1, 1936."

2. Regulation 21 of the Regulations for Secondary Teachers (Northern Ireland), 1935, (hereinafter called the "Principal Regulations") is hereby repealed and the following substituted therefor :—

21. The scales of salary prescribed in Regulation 23 as amended by these Regulations shall remain in force until such time as they are varied by Regulations made by the Ministry after consultation with the Ministry of Finance and shall take and have effect as from the 1st August, 1936, subject to the following provisions :—

- (1) A teacher who on 1st August, 1936, would normally be entitled to be paid at the maximum of his scale shall receive from that date one half of the increment by which his salary was reduced on the scale operative prior to 1st August, 1936, and the remaining half from 1st August, 1937.
- (ii) (a) A teacher who on 1st August, 1936, has not reached the maximum of his scale, and who would normally be

entitled to an increment as from that date, shall receive such increment on the scale operative prior to the 1st August, 1936, together with one half of the increment by which his salary was reduced on that scale, and shall be placed as from 1st August, 1937, at the point on his scale set forth below to which his service entitles him ;

(b) A teacher who on 1st August, 1936, has completed his probationary period, but who has not reached the maximum of his scale, if he would not normally be entitled to an increment until a later date, shall receive as from 1st August, 1936, one half of the increment by which his salary was reduced on the scale operative prior to that date, and shall be placed at the point on his scale set forth below to which his service entitles him as from the later date upon which his increment is payable.

Provided, however, that a teacher referred to in (a) or (b) shall not receive a salary less than he would have received but for the formulation of these Regulations.

3. Regulation 23 of the Principal Regulations is hereby repealed and the following substituted therefor :—

23. The minimum scales of salary for full time certified teachers on the authorised staff shall be as set forth below :—

#### I. *Ordinary Scale.*

##### *Secondary Teachers :*

Men : £210 per annum rising by annual increments of £10 to £260 and thence by annual increments of £15 and one final increment of £10 to £450.

Women : £200 per annum rising by annual increments of £8 to £232 and thence by annual increments of £10 and one final increment of £3 to £325.

##### *Preparatory Teachers :*

Men : £160 per annum rising by annual increments of £10 to £210 and thence by annual increments of £15 and one final increment of £10 to £400.

Women : £150 per annum rising by annual increments of £8 to £182 and thence by annual increments of £10 and one final increment of £8 to £300.

#### II. *Honours Scale.*

In the case of full-time certified teachers on the authorised staff who have obtained, prior to or subsequent to entry upon the scales, a degree with first or second class honours in a British or

Irish University, or who have obtained other qualifications judged by the Ministry as equivalent thereto, the minimum scales shall be :—

*Secondary Teachers :*

Men : £210 per annum rising by annual increments of £10 to £260 and thence by annual increments of £15 to £500.

Women : £200 per annum rising by annual increments of £8 to £232 and thence by annual increments of £10 and one final increment of £3 to £375.

*Preparatory Teachers :*

Men : £160 per annum rising by annual increments of £10 to £210 and thence by annual increments of £15 to £450.

Women : £150 per annum rising by annual increments of £8 to £182 and thence by annual increments of £10 and one final increment of £8 to £350.

4. These Amending Regulations shall take and have effect as from the 1st August, 1936, and shall thenceforth be construed with and as forming part of the Principal Regulations.

### **Public Elementary Schools : Regulations.**

REGULATIONS, DATED 17TH JUNE, 1936, MADE BY THE MINISTRY OF EDUCATION FOR NORTHERN IRELAND, UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1923 TO 1935, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE AND DULY LAID BEFORE PARLIAMENT.

The Public Elementary Schools Regulations, 1934 (Statutory Rules and Orders of Northern Ireland, 1934, No. 40) (hereinafter called the "Principal Regulations") and the Public Elementary Schools Regulations, 1934, Amending Regulations, No. 1, 1935 (Statutory Rules and Orders of Northern Ireland, 1935, No. 69) (hereinafter called the "Amending Regulations No. 1, 1935") are hereby amended as follows :—

1. Article 118 of the Principal Regulations is hereby repealed.
