Sale of Diseased Plants.

THE SALE OF DISEASED PLANTS (NORTHERN IRELAND) ORDER OF 1936, DATED 11TH DAY OF APRIL, 1936.

1936. No. 40.

The Ministry of Agriculture for Northern Ireland by virtue and in exercise of the powers vested in it under the Destructive Insects and Pests Acts (Northern Ireland), 1877 to 1934, and of every other power enabling it in that behalf, orders, and it is hereby ordered as follows:—

Amendment of The Sale of Diseased Plants (Northern Ireland) Order of 1927.

1. The Sale of Diseased Plants (Northern Ireland) Order of 1927 (hereinafter referred to as the "principal Order") is hereby amended in the manner provided in this Order.

Extension of Principal Order.

- 2.—(a) In Article 2 of the principal Order, there shall be inserted after the word "planting" the words "or having sold, shall deliver or cause to be delivered for planting."
- (b) In Article 8 of the principal Order, there shall be inserted after the word "planting" the words "or having sold, delivers or causes to be delivered for planting."
- (c) For the word "attacked" wherever it appears in the principal Order, there shall be substituted the word "affected."
- (d) The expression "any plant substantially attacked by any insect or pest mentioned in the Schedule to this Order" in the principal Order shall be deemed for all the purposes of that Order to include any tomato or cucumber plant which is substantially affected by the insect or pest known as "Greenhouse White Fly" (Trialeurodes vaporarium Westd.); and any potatoes or Narcissus plants or bulbs which are visibly rendered unfit for planting by reason of their being or having been affected by any insect or pest.

Amendment of Article 8 of the principal Order.

3. Article 8 of the principal Order shall be read and have effect as if after the words "a penalty not exceeding ten pounds" the following words were inserted therein, namely, "or, in respect of a second or subsequent offence, to a penalty not exceeding fifty pounds."

Definition.

4. "Narcissus plants or bulbs" includes Daffodil plants of bulbs.

Short Title.

5. This Order may be cited as the Sale of Diseased Plants (Northern Ireland) Order of 1936, and shall be read as one with the principal Order, and the principal Order and this Order may be cited together as the Sale of Diseased Plants (Northern Ireland) Orders of 1927 and 1936.

Commencement.

6. This Order shall come into operation on the first day of May, nineteen hundred and thirty-six.

REGULATIONS, DATED 20TH OCTOBER, 1936, MADE BY THE MINISTRY OF AGRICULTURE, NORTHERN IRELAND, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE UNDER THE PROVISIONS OF SECTION 99 OF THE EDUCATION ACT (NORTHERN IRELAND), 1923 (13 AND 14 GEO, 5, CH. 21), AS APPLIED BY THE ORDER DATED 29TH DAY OF MAY, 1925, OF THE GOVERNOR OF NORTHERN IRELAND IN COUNCIL, AND LAID BEFORE PARLIAMENT IN ACCORDANCE WITH THE SAID PROVISIONS.

1. These Regulations may be cited as the Agricultural Teachers
