

(2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.

2. The Unemployment Insurance (Collection of Contributions) Regulations, 1920, shall be read and have effect as if the following amendments were made therein :—

(a) For paragraph (1) of Regulation 9 there shall be substituted the following paragraph :—

“(1) Every contribution payable under the general provisions of the Act shall, except as herein otherwise provided, be paid by the affixing of a stamp to the book of the insured contributor in the space indicated for the purpose upon the book :

Provided that payment of an agricultural contribution shall, except as otherwise provided, be made by means of an agricultural stamp, and no such stamp shall be used for the purpose of paying any contribution other than an agricultural contribution.”

(b) In Regulation 16, after the word “contribution,” there shall be inserted the words “other than an agricultural contribution.”

ORDER IN COUNCIL, DATED 16TH APRIL, 1936, MADE UNDER
THE UNEMPLOYMENT ACT (NORTHERN IRELAND), 1934

ABERCORN.

WHEREAS by section eighteen of the Unemployment Act (Northern Ireland), 1934, as amended by the Fourth Schedule to the Unemployment Insurance (Agriculture) Act (Northern Ireland), 1936, it is provided that in the event of an order being made at any time under Part IV. of the Unemployment Insurance Act, 1935, passed by the Parliament of the United Kingdom, for

the amendment of any provisions of that Act applying to Great Britain (hereinafter referred to as a "statutory order"), then in that event there shall apply to Northern Ireland so much as the Governor of Northern Ireland by Order in Council declares applicable of the provisions contained in such statutory order :

And whereas it is further provided in the said section that an Order in Council thereunder may make such adaptations of any provisions contained in any statutory order as appear necessary or expedient for carrying into effect the application of those provisions to Northern Ireland, and that as from any date specified in such Order in Council the Unemployment Insurance Acts as applying in Northern Ireland shall have effect subject to the provisions of the statutory order applied to Northern Ireland by such Order in Council.

And whereas a statutory order has been made for the amendment of the Third Schedule to the Unemployment Insurance Act, 1935, by reducing the weekly rates of contributions payable in respect of certain classes of employed persons :

Now, therefore, I, James Albert Edward, Duke of Abercorn, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of Saint Patrick, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in pursuance of the provisions of the said section eighteen and of all other powers enabling me in that behalf, do hereby declare that so much of the provisions contained in the aforesaid statutory order as provides for such amendment as aforesaid is applicable to Northern Ireland :

And I do hereby order as follows :—

1. For carrying into effect the application of the said provisions to Northern Ireland, article 2 of the said statutory order shall be adapted to such extent as may be necessary so that the same may be read and have effect as follows :—

There shall be substituted for the First Schedule to the Unemployment Insurance (Economy) (No. 1) Order (Northern Ireland), 1931 (which sets out weekly rates of contributions payable by employers and employed persons) the following Schedule :—

FIRST SCHEDULE.

WEEKLY RATES OF CONTRIBUTIONS PAYABLE BY EMPLOYERS AND EMPLOYED PERSONS.

Class of employed person to whom rate applies.	Weekly Rate of Contribution.	
	By the employed person.	By the employer
Men who have attained the age of 21 years ..	9d.	9d.
Women who have attained the age of 21 years	8d.	8d.
Young men between the ages of 18 and 21 years	8d.	8d.
Young women between the ages of 18 and 21 years	7d.	7d.
Boys between the ages of 16 and 18 years ..	5d.	5d.
Girls between the ages of 16 and 18 years ..	4½d.	4½d.

2. The date as from which the Unemployment Insurance Acts as applying in Northern Ireland are to have effect subject to the provisions of the statutory order applied as aforesaid is the 6th day of July, 1936.

3. This Order may be cited as the Unemployment Insurance (Reduction in the Weekly Rates of Contributions) Order (Northern Ireland), 1936.
