

- (c) The following provision shall be added to paragraph 24 of the said Scheme at the end of that paragraph, that is to say:—

“ Provided that nominations of candidates for election to the Board in 1937 by registered producers who privately own or occupy the premises at which butter or cream is produced must be lodged with the Ministry not later than the 20th day of April, 1937. A candidate for such election may withdraw his candidature by sending to the Secretary, Ministry of Agriculture, Stormont, Belfast, by registered post, not later than the 26th day of April, 1937, a notice in writing of such withdrawal signed by him.”

- (d) The following provision shall be added to paragraph 27 of the said Scheme at the end of that paragraph, that is to say:—

“ Provided that in the case of the election of a member to the Board in 1937 by registered producers who privately own or occupy the premises at which butter or cream is produced voting papers shall be sent by post by the Ministry not later than the 28th day of April, 1937, to every producer whose name appeared on the register of producers on the 1st day of February, 1937. Only such of the said voting papers as are properly completed and reach the Ministry on or before the 5th day of May, 1937, shall be taken into account.”

2. This Order may be cited as the Butter and Cream Marketing Scheme (Northern Ireland) Amendment (No. 1) Order, 1937, and shall come into operation on the date hereof.

### **Pig Industry : Form of Curers' Returns.**

THE MARKETING OF PIGS (FORM OF CURERS' RETURNS) (AMENDMENT) REGULATIONS (NORTHERN IRELAND), 1937, DATED 12TH AUGUST, 1937, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION TEN AND SECTION TWELVE OF THE AGRICULTURAL MARKETING (PIG INDUSTRY) ACT (NORTHERN IRELAND), 1934. (25 GEO. 5, CH. 3).

WHEREAS by Section Ten of the Agricultural Marketing (Pig Industry) Act (Northern Ireland), 1934, (hereinafter referred to as "the Act") it is provided *inter alia* that every licensed bacon-curer shall keep such records, and furnish to the Ministry of Agriculture (hereinafter referred to as "the Ministry") such returns and other information, in relation to---

- (a) his production of bacon ; and
- (b) his purchases of pigs for curing into bacon, and his sales of bacon (including prices paid and obtained) ;

as may be prescribed by the Ministry, and shall permit the said records to be inspected, and extracts therefrom to be taken, by an officer of, and authorised by, the Ministry :

And whereas it is provided by Section Twelve of the Act that the Ministry may make regulations prescribing anything which is to be prescribed :

And whereas the Ministry has made regulations entitled " The Marketing of Pigs (Form of Curers' Returns) Regulations. (Northern Ireland), 1936," dated 19th December, 1936 :

Now, therefore, the Ministry in exercise of the powers conferred upon it by the said sections of the Act and of every other power enabling it in that behalf hereby makes the following regulations, that is to say :—

*Amendment of Form of Curers' Returns.*

1. The form of return prescribed in the First Schedule to " The Marketing of Pigs (Form of Curers' Returns) Regulations (Northern Ireland), 1936 " shall be read and have effect with the following amendments—

- (a) the words—  
     " Sales of dried (including smoked) 10's, 11's and  
        12's rolls " shall be substituted for the words—  
     " Sales of dried (including smoked) 10's rolls "
- (b) the words—  
     " Sales of dried (including smoked) hams (12—24 lb.)  
   in Northern Ireland "   
   do.    outside Northern Ireland "   
     shall be substituted for the words—  
     " Sales of dried (including smoked) hams (16—24 lb.)  
   in Northern Ireland "   
   do.    outside Northern Ireland. "
- (c) the words—  
     " Other Green Bacon "   
     " Dried Bacon "   
     shall be substituted for the words—  
     " Green Bacon—2nd Quality "   
     " Other Bacon. "

*Short Title and Commencement.*

2. These Regulations may be cited as the Marketing of Pigs (Form of Curers' Returns) (Amendment) Regulations (Northern Ireland), 1937 and shall come into operation on the 23rd day of August, 1937.

THE PIGS MARKETING (GRADING) (NORTHERN IRELAND) ORDER, 1936, (AMENDMENT) ORDER, 1937, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION 7 (1) OF THE AGRICULTURAL MARKETING (PIG INDUSTRY) ACT (NORTHERN IRELAND), 1934 (25 GEO. V, CH. 3).

The Ministry of Agriculture for Northern Ireland by virtue and in exercise of the powers conferred on it by Section 7 (1) of the Agricultural Marketing (Pig Industry) Act (Northern Ireland), 1934, and of every other power enabling it in that behalf orders and it is hereby ordered as follows :—

*Amendment of First Schedule of the Pigs Marketing  
(Grading) (Northern Ireland) Order, 1936.*

1. (A) Part I of the First Schedule to the Pigs Marketing (Grading) (Northern Ireland) Order, 1936 (hereinafter referred to as the principal Order) shall be read and have effect as if the following were substituted therefor :—
