

2. This Order shall have effect from the 22nd March, 1937.

3.—(1) Nothing contained in sub-paragraph (a) of paragraph 1 of this Order shall affect the computation of the number of additional days in any claim year which began before 1st January, 1937 ;

(2) Nothing contained in sub-paragraph (b) of paragraph 1 of this Order shall entitle any person to receive benefit in respect of any day before the 25th March, 1937, to which he would not have been entitled if this Order had not been made.

4. This Order may be cited as the Unemployment Insurance (Insurance Industry Special Scheme) (Variation and Amendment) Order (Northern Ireland), 1937, and this Order and the Unemployment Insurance (Insurance Industry Special Scheme) Orders (Northern Ireland), 1921 to 1936, may be cited together as the Unemployment Insurance (Insurance Industry Special Scheme) Orders (Northern Ireland), 1921 to 1937, and shall be construed as one.

### Mercantile Marine.

THE UNEMPLOYMENT INSURANCE (MERCANTILE MARINE EXCLUSION) REGULATIONS (NORTHERN IRELAND), 1937, DATED 28TH AUGUST, 1937, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE UNEMPLOYMENT INSURANCE ACT (NORTHERN IRELAND), 1936 (26 GEO. 5 and 1 EDW. 8, c. 30).

WHEREAS by virtue of the provisions of section 120 (3) of the Unemployment Insurance Act (Northern Ireland), 1936, the Special Orders set out in the Schedule hereto have effect as if they were Regulations made under section 106 of the said Act ;

Now therefore the Ministry of Labour for Northern Ireland by virtue of the powers conferred on it by the said section 106, and of all other powers in that behalf, after consultation with the Board of Trade, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Unemployment Insurance (Mercantile Marine Exclusion) Regulations (Northern Ireland), 1937, and shall come into force on the date hereof.

(2) The Interpretation Act, 1921,\* applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.

(3) The Special Orders set out in the Schedule hereto are hereby revoked, but such revocation shall not affect any right, privilege, obligation, or liability acquired, accrued or incurred under those Special Orders, or anything done or to be done thereunder.

2.—(1) In these Regulations unless the context otherwise requires the following expressions have the meanings hereby respectively assigned to them, that is to say:—

“the Act” means the Unemployment Insurance Act (Northern Ireland), 1936;

“Governing Body” means the body in which the Seamen’s Special Fund is vested and by which it is administered;

“the Ministry” means the Ministry of Labour for Northern Ireland;

“Scheme” means the scheme prepared by the Governing Body for the purpose of the Seamen’s Special Fund;

“Seamen’s Special Fund” means the special fund to which are credited contributions paid by employers under the National Health Insurance Act, 1936, in respect of masters, seamen and apprentices to the sea service or sea fishing service who are neither domiciled nor have a place of residence in the United Kingdom;

“ship engaged in regular trade on foreign stations” has the same meaning as in section 226 of the National Health Insurance Act, 1936.

(2) Unless the context otherwise requires, any reference in these Regulations to the Unemployment Insurance Act (Northern Ireland), 1936, shall be construed as a reference to that Act as amended by any order or subsequent enactment.

3. Any master, seaman or apprentice to the sea service or sea fishing service who is neither domiciled nor has a place of residence in the United Kingdom shall be excluded from the provisions of the Act, but the employer of any such master, seaman or apprentice shall be liable to pay the like contribution as would have been payable by him as an employer’s contribution if such master, seaman or apprentice had been an employed person:

Provided that no such contributions shall be payable in respect of any such persons who are—

(a) employed in a ship engaged in regular trade on foreign stations, or

(b) over 65 years of age.

4. Contributions paid by employers under Regulation 3 hereof shall be credited to the Seamen’s Special Fund and shall be applied by the Governing Body to the provision of such benefits

specified in the Scheme as may be approved by the Ministry and the Board of Trade.

**Mixed Employment.**

THE UNEMPLOYMENT INSURANCE (MIXED EMPLOYMENT) REGULATIONS (NORTHERN IRELAND), DATED THE 30TH DAY OF APRIL, 1937, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE UNEMPLOYMENT INSURANCE ACT (NORTHERN IRELAND), 1936 (26 GEO. 5, & 1 EDW. 8, c. 30).

The Ministry of Labour for Northern Ireland in exercise of the powers conferred on it by section 3 of the Unemployment Insurance Act (Northern Ireland), 1936, and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Unemployment Insurance (Mixed Employment) Regulations (Northern Ireland), 1937, and shall come into force on the date hereof.

(2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.

2.—(1) In these Regulations, unless the context otherwise requires the following expressions have the meanings hereby respectively assigned to them, that is to say:—

“The Act” means the Unemployment Insurance Act (Northern Ireland), 1936, and shall be construed as a reference to that Act as amended by any order or subsequent enactment.

“The Ministry” means the Ministry of Labour for Northern Ireland.
