

Milk Regulations : Grade B.

THE MILK (GRADE B) (AMENDMENT) REGULATIONS (NORTHERN IRELAND), 1937, DATED THE 30TH DAY OF AUGUST, 1937, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION NINE OF THE MILK AND MILK PRODUCTS ACT (NORTHERN IRELAND), 1934. (24 AND 25 GEO. V. CH. 16).

The Ministry of Agriculture for Northern Ireland in exercise of the powers conferred on it by Section Nine of the Milk and Milk Products Act (Northern Ireland) 1934, and of any other powers enabling it in that behalf, hereby makes the following Regulations, that is to say :—

Conditions to be complied with by a producer.

1. Article 13 of the Milk (Grade B) Regulations (Northern Ireland) 1934(a), (hereinafter referred to as the principal Regulations) as amended by the Milk (Grade B) (Amendment) Regulations (Northern Ireland) 1935(b), the Milk (Grade B) (Amendment) (No. 2) Regulations (Northern Ireland) 1935(c) and the Milk (Grade B) (Amendment) (No. 2) Regulations (Northern Ireland) 1936(d) (hereinafter referred to as the "amending Regulations") shall have effect as if—

- (a) in relation to the holder of a producer's licence who sells milk to the holder of a distributor's licence under a contract registered by the Joint Milk Council the word "third" were substituted for the word "fourteenth," and
- (b) in the proviso thereto the words "30th day of September, 1938" were substituted for the words "31st day of August, 1937."

Conditions to be complied with by a distributor.

2. Article 19 of the principal Regulations as amended by the amending Regulations shall have effect as if—

- (a) in relation to the holder of a Distributor's licence who purchases milk from the holder of a Producer's licence under a contract registered by the Joint Milk Council the word "third" were substituted for the word "fourteenth," and
- (b) in the proviso thereto the words "30th day of September, 1938" were substituted for the words "31st day of August, 1937."

Short Title.

3. These Regulations may be cited as the Milk (Grade B) (Amendment) Regulations (Northern Ireland), 1937, and these Regulations, the principal Regulations and the amending

Milk Regulations : Grade C.

THE MILK (GRADE C) (AMENDMENT) REGULATIONS (NORTHERN IRELAND), 1937, DATED THE 30TH DAY OF AUGUST, 1937, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION NINE OF THE MILK AND MILK PRODUCTS ACT (NORTHERN IRELAND), 1934. (24 AND 25 GEO. V. CH. 16).

The Ministry of Agriculture for Northern Ireland in exercise of the powers conferred on it by Section Nine of the Milk and Milk Products Act (Northern Ireland), 1934, and of any other powers enabling it in that behalf, hereby makes the following Regulations, that is to say :—

1. Article 12 of the Milk (Grade C) Regulations (Northern Ireland) 1934(a) (hereinafter referred to as the "principal Regulations") as amended by the Milk (Grade C) (Amendment) Regulations (Northern Ireland) 1935(b); the Milk (Grade C) (Amendment) (No. 2) Regulations (Northern Ireland) 1935(c) and the Milk (Grade C) (Amendment) (No. 2) Regulations (Northern Ireland) 1936(d) (hereinafter referred to as the "amending Regulations") shall have effect as if—

(a) in relation to the holder of a producer's licence who sells milk to the holder of a distributor's licence under a contract registered by the Joint Milk Council the word "third" were substituted for the word "fourteenth," and

2. Article 17 of the principal Regulations as amended by the amending Regulations shall have effect as if—
