(i) Otherwise than within the meaning of paragraphs 1 and 2 of Part I. of the First Schedule to the Act, in the execution of contracts not requiring

personal service on the part of the employed person;
As a contractor with the authority for the construction, maintenance, improvement, or repair of roads or other public works, unless he is mainly dependent for his livelihood on his earnings from such employment, or the employment is under a contract of service.

Employment under a Board of Guardians:-

(a) As a pauper; (b) In rearing boarded-out pauper children.

Employment as a pilot under the Londonderry Port and Harbour Commissioners.

Inconsiderable Employments.

THE UNEMPLOYMENT INSURANCE (INCONSIDERABLE EMPLOY-MENTS) REGULATIONS (NORTHERN IRELAND), 1937, DATED THE 22ND DAY OF SEPTEMBER, 1937, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER SECTION 3 OF THE UNEMPLOYMENT INSURANCE ACT (NORTHERN IRELAND), 1936.

> 1937. No. 85.

The Ministry of Labour for Northern Ireland, by virtue of the powers conferred on it by Section 3 of the Unemployment Insurance Act (Northern Ireland), 1936, and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

- 1. There shall be added to the excepted employments the classes of employment specified in the first column of the Schedule hereto, subject to the conditions and exceptions and only as respects the persons who are employed to the extent specified in the second column of the said Schedule.
- 2. In these Regulations the expression "week" means the period of 7 days commencing at midnight between Sunday and Monday.
- 3.—(1) These Regulations may be cited as the Unemployment Insurance (Inconsiderable Employments) Regulations (Northern Ireland), 1937, and shall come into force on the date hereof.
- (2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.
- (3) The Unemployment Insurance (Inconsiderable Employments) Regulations (Northern Ireland), 1936(a) and the Un-

employment Insurance (Inconsiderable Employments) Amendment Regulations (Northern Ireland), 1936,(b) are hereby revoked, but such revocation shall not affect any right, privilege, obligation or liability acquired, accrued or incurred under these Regulations, or anything done or to be done thereunder.

SCHEDULE.

Classes of employment to be added to the excepted employments as respects persons employed therein, subject to the conditions and exceptions and to the extent in any week therein specified.

Classes of Employment.

Persons affected and extent.

- All classes of employment which, but for these Regulations, would be insurable employment.
- 1. (a) Persons of the age of 16 years or over(other than persons employed in loading, unloading, moving or handling goods in, on or at any dock, wharf or quay or in loading, unloading or coaling any ship in any dock, harbour or canal or in assisting in the navigating or mooring of vessels in or in the neighbourhood of any dock, harbour or canal if they are normally employed in any such omployment, and persons employed in taking or assisting in taking vessels into or out of dry dock), if and to the extent that they are employed in any week by or under any one employer for less than 4 hours in that week; and
- (b) Persons who have attained the minimum age for entry into insurance, if and to the extent that they are employed in any week by or under any one employer in employment which does not exceed in length a normal working day, where such employment occurs:—

(i) only on a Sunday in any week, and the person employed is also employed in insurable employment by or under the same employer on the Monday in the succeeding week, or

- (ii) only on a Monday in any week, and the person employed has also been employed in insurable employment by or under the same employer on the Sunday and on at least one other day in the preceding week.
- 2. Employment in clearing snow, which, but for these Regulations, would be insurable employment.
- 2. Persons of the age of 16 years or over if and to the extent that they are employed in any week by or under any one employer on not more than 4 days in that week.
