butter from the milk supplies of several cow-keepers; and (iii) processed milk factories engaged in the manufacture, from the milk supplies of several cow-keepers, of such milk products other than butter and cream as may be prescribed by the Ministry of Agriculture shall in respect of such milk so delivered during the period beginning on the 1st day of October, 1938, and ending on the 31st day of March, 1939, be of such sum as will raise the average price paid by all creameries for such milk to six pence halfpenny per gallon; and shall in respect of such milk so delivered during the period beginning on the 1st day of April, 1939, and ending on the 30th day of September, 1939, be of such sum as will raise the average price paid by all creameries for such milk to five pence per gallon.

REGULATIONS, DATED 30TH AUGUST, 1938, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION NINE OF THE MILK AND MILK PRODUCTS ACT (NORTHERN IRELAND), 1934.

> No. 110. 1938.

The Ministry of Agriculture, in exercise of the powers conferred on it by Section nine of the Milk and Milk Products Act (Northern Ireland), 1934, and of any other powers enabling it in that behalf, hereby makes the following regulations, that is to say:—

Bonus.

1.—The bonus payable out of the Milk Fund under sub-section (3) section eleven of the Act in respect of milk of Grade A delivered by the holder of a Producer's licence to a processed milk factory and used for the manufacture of the prescribed milk products shall be twopence per gallon.

Amendment of the principal Regulations.

2.—The Milk (Grade A) Regulations (Northern Ireland), 1934(a), as amended by subsequent Regulations shall have effect as if the amendments specified in the second column of the Schedule to these Regulations were made in the Articles specified in the first column of that Schedule.

Short Title

3.—These Regulations may be cited as the Milk (Grade A) Construction (Amendment) Regulations (Northern Ireland), 1938, and these Regulations and the Milk (Grade A) (Amendment) Regulations

To paragraph (2) (a) there shall be added the words "or to a processed milk factory (if any) for the purpose of the manufacture of a prescribed milk product."

In paragraph (2) (b) there shall, after the word "creamery," be inserted the words "or to a processed milk factory."

Article 17.

The words "otherwise than to the holder of a Distributor's licence, to a creamery for the purpose of the extraction of cream for sale as such, or for manufacture into butter, or to a processed milk factory for the manufacture of a prescribed milk product" shall be substituted for the words "otherwise than to the holder of a Distributor's licence or to a creamery for the purpose of the extraction of cream for sale as such or for manufacture into butter."

Article 24.

In paragraph (2) there shall be inserted after the word "creamery" the words "or to a processed milk factory."
