

WEIGHTS AND MEASURES.**Weights and Measures Act, 1938: Appointed Day.**

ORDER, DATED THE FOURTH DAY OF OCTOBER, 1938, MADE BY THE MINISTER OF COMMERCE UNDER SECTION 10 OF THE WEIGHTS AND MEASURES ACT (NORTHERN IRELAND), 1938.

1938. No. 118.

WHEREAS by Section 10 of the Weights and Measures Act (Northern Ireland), 1938 (hereinafter referred to as "the Act"), it is provided that the Act shall come into operation on the appointed day and that the appointed day for the purposes of the Act shall be such day as the Minister of Commerce may appoint :

And whereas it is expedient that a day be appointed for the coming into operation of the provisions of the Act :

Now therefore, I, the Right Honourable J. Milne Barbour, D.L., M.P., Minister of Commerce for Northern Ireland, hereby appoint the first day of November, 1938, to be the appointed day for the coming into operation of the provisions of the Act.
