And whereas it is expedient that a day be appointed for the coming into operation of the provisions of the Act:

Now therefore, I, the Right Honourable J. Milne Barbour, D.L., M.P., Minister of Commerce for Northern Ireland, hereby appoint the first day of November, 1938, to be the appointed day for the coming into operation of the provisions of the Act.
