Britain in respect of which, if that employment had been carried on in Northern Ireland, contributions would have been payable under those Acts."

- (2) sub-section (2) of Section 31 shall apply as though it included a reference to a training course or course of instruction in Great Britain.
- (3) Section 37 shall apply as though so much of an allowance granted under the Unemployment Assistance Act, 1934, as is granted for the maintenance of the applicant at a training course or course of instruction were an allowance granted under the Act.
- 3.—The Interpretation Act, 1921, applies to the interpretation of these Rules as it applies to the interpretation of an Act of Parliament.
- 4.—These Rules may be cited as the Unemployment Assistance (Reciprocal Arrangements with Great Britain) Rules (Northern Ireland), 1938, and shall come into force on the day after the day on which they are confirmed by the Minister of Labour.

## Winter Adjustments.

THE UNEMPLOYMENT ASSISTANCE (WINTER ADJUSTMENTS)
REGULATIONS (NORTHERN IRELAND), 1938, DATED 19TH
SEPTEMBER, 1938, MADE BY THE MINISTRY OF LABOUR FOR
NORTHERN IRELAND UNDER THE UNEMPLOYMENT ASSISTANCE
ACT (NORTHERN IRELAND), 1934 (24 AND 25 GEORGE 5,
CHAPTER 12).

WHEREAS the Ministry of Labour for Northern Ireland (hereinafter referred to as "the Ministry"), in pursuance of the powers conferred on it by the Unemployment Assistance Act (Northern Ireland), 1934 (hereinafter referred to as "the Act"), duly made, for the purposes of the Act, the Unemployment Assistance (Determination of Need and Assessment of Needs) Regulations (Northern Ireland), 1936(a) (hereinafter referred to as "the principal Regulations");

AND WHEREAS it is expedient that further provision should be made for the purposes aforesaid;

NOW THEREFORE the Ministry by virtue of the powers conferred on it by Sections 33 and 46 of the Act and of all other powers in that behalf hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Unemployment short Assistance (Winter Adjustments) Regulations (Northern Ireland), commencement and these Regulations and the principal Regulations may interprebe cited together as the Unemployment Assistance (Determination tation) of Need and Assessment of Needs) Regulations Ireland), 1936 and 1938;

- (2) These Regulations shall come into force on hereof;
- (3) The Interpretation Act, 1921, applies to the interpretation. of these Regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
- 2.—Without prejudice to the generality of any power of adjust-ment of ment conferred by the principal Regulations, the amount at which ments the needs of an applicant for an allowance under the Act would to meet winter be assessed in accordance with those Regulations may, in a case conditions. where special needs due to winter conditions exist, be increased to meet such needs by such amount as is reasonable in all the circumstances of the case.
